ORDER

WHEREAS, a copy of order dated 25.11.2021 passed by Hon'ble High Court of Delhi at New Delhi in W.P.(C) 1329/2021 was received in ERC NCTE along with the representation vide letters dated 26.11.2021 and 03.02.2022 from Dr. Rajneesh Ranjan, Chairman of the institution viz. **Ramchandra Vidyapeeth, Narayan Vihar, Soha, SH-59, Sonbarsa Raj, Dist. Saharsa, State-Bihar, Pin Code – 852129** stating therein that no action has been taken by ERC NCTE on their application (ID-11307) for grant of recognition to B.Ed. and D.El.Ed. course and no information given by ERC NCTE to the institution.

2. **AND WHEREAS**, the ERC in its 302nd (Virtual) meeting held on 28th February & 1st March, 2022 considered the matter in compliance of Order dated 25.11.2021 of the Hon'ble High Court of Delhi and the Committee made following observations:

“In compliance of the Order dated 25.11.2021 passed by Hon'ble High Court of Delhi at New Delhi in W.P.(C) 13291/2021 received in ERC NCTE along with the representation vide its letters dated 26.11.2021 and 03.02.2022 submitted by the institution, the ERC carefully considered the case and made following observations:

- As per ERC office database and records, the institution has not made any application for grant of recognition for B.Ed. and D.El.Ed. course on 29.06.2016.
- Due to non-receipt of any online application bearing ID No.11307, Application No.ERCAPP201646329 from the institution, the office ERC has not processed any such application of the institution.
- On further perusal of illegible copy of Bank Challan related to deposit slip of processing fee of Rs.3.00 lakh attached with the offline application submitted now by the institution claiming that they have submitted the same earlier before the Hon'ble High Court of Delhi, it is found that the Application No.ERCAPP201646329 mentioned in the bank challan deposit slip pertains to a different institution of West Bengal viz. Pailan College of Education, Vill - Kolkata, Street/Road - Bengal Pailan Park, Sector 1, Phase 1, Amgachia Road, Taluka/Mandal - Pailan, PS- Bishnupur, Town/City - Kolkata, West Bengal – 7000104 (Application No.ERCAPP201646329) (ID-10857) which has been granted recognition by ERC, NCTE for M.Ed. course with intake of 50 from the academic session 2018-2019 vide Order No.55657 dated 09.01.2018. By mentioning another institution's online application number in proof of copy of bank deposit slip of processing fee attached, the institution has furnished false information to ERC, NCTE.
- As confirmed by the Accounts Section, NCTE HQrs. attaching a copy of bank statement dated 01.04.2016 to 31.03.2017 and also by IT & e-Gov Sections of NCTE, New Delhi, the online processing fee of Rs.3,00,000 lakh has not been received from the institution by NCTE.
- As per the contention of the institution before the Hon'ble Court, no any application is pending at ERC, NCTE.

An F.I.R. be lodged against the institution for producing false information to ERC, NCTE and the same be informed to the Standing Counsel, NCTE.”


3. **AND WHEREAS**, the matter of issuance of action taken on the decision taken by 302nd ERC meeting was under process and in the meantime, Mr. Rajneesh Ranjan, Chairman of the institution viz. Ramchandra Vidyapeeth, Narayan Vihar, Soha, SH-59, Sonbarsa Raj, Dist. Saharsa, State-Bihar, Pin Code – 852129 has submitted a letter connected with the decision of 302nd ERC meeting vide No.RV/NCTE/19 DATED 09.03.2022 (received on 21.03.2022), attaching an original affidavit on E-Court Fee stamp paper attested by Notary Public dated 09.03.2022 stating therein that this work has probably been done by the former staff of his organization out of malice and he also stated in the said affidavit that he withdraws the case filed against the ERC, NCTE before the Hon’ble Court and also stated that not to challenge any decision taken by ERC NCTE pertaining to their institution before the Hon’ble Court. By this, the representative of the institution has prayed for apologizing the institution and to take appropriate decision with sympathy towards their organization.

4. **AND WHEREAS**, the ERC in its 303rd (Virtual) meeting held on 24th March, 2022 considered the original affidavit wherein the representative of the institution has prayed for unconditional apology and the Committee made following observations and decided as under:

“The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC and the Committee made following observations:-

- iv. As confirmed by the Accounts Section, NCTE HQrs. attaching a copy of bank statement dated 01.04.2016 to 31.03.2017 and also by IT & e-Gov Sections of NCTE, New Delhi, the online processing fee of Rs.3.00 lakh has not been received from the institution by NCTE.
- v. As per the contention of the institution before the Hon'ble Court, no any application is pending at ERC, NCTE.

In view of the above, the Committee decided as under:-


1. The institution has submitted representation letter dated 26.11.2021 and 03.02.2022 for processing of B.Ed and D.El.Ed course.
2. The institution has again submitted representation/request with unconditional apology dated 21.03.2022 on Non judicial stamp paper of Rs.100/-.
3. The request / representations submitted by the institution considered and decided that the application is refused U/s 14/15(3)(b) of the NCTE Act, 1993.
4. It was further decided that the earlier decision of the complaint i.e. lodging of the complaint against institute is will still stand valid."
5. **NOW THEREFORE**, as per the decision of 303rd (Virtual) ERC Meeting, the application for B.Ed. and D.El.Ed. course in respect of institution viz. **Ramchandra Vidyapeeth, Narayan Vihar, Soha, SH-59, Sonbarsa Raj, Dist. Saharsa, State-Bihar, Pin Code – 852129** is hereby **refused under Section 14/15(3)(b) of NCTE Act, 1993**. The action regarding filing of complaint against the institution, as decided by ERC in its 303rd (Virtual) Meeting, is being made separately.
6. Further, if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website (www.ncte.gov.in) within 60 days from the date of the issue of the order.
