WITHDRAWAL ORDER

WHEREAS, recognition was granted to the institution namely **VITHOBAJI AMLE COLLEGE OF EDUCATION, BRAHMAPURI, CHANDRAPUR, MAHARASHTRA** vide Order No. WRC/5-6/19/99/1571-73 dt. 03.03.2000 for **B.Ed.** course with an annual intake of 80 students for the academic session 2000-2001.

AND, WHEREAS, the revised recognition Order was issued to the institution namely **VITHOBAJI AMLE COLLEGE OF EDUCATION, WADSA ROAD, BRAHMAPURI, CHANDRAPUR, MAHARASHTRA-441206** vide order no. **WRC/OAPW0516/113069/APW01926/113069/2015/146160,162,164,166,167,169,170** dt. **31.05.2015** for **B.Ed.** course of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16 with following conditions: -

- > The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- > The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
- > The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- > In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Western Regional Committee in respect of Section 17/complaint cases etc.

AND WHEREAS, the institution has not complied with the conditions of revised recognition order. The matter was considered by WRC in its 255th meeting and Committee decided to issue Show Cause Notice u/s 17 of NCTE Act 1993 on the following points: -

- > **Staff Profile for the session 2015-16 duly approved by the affiliating body.**
- > **Originally notarized Change of land Use/Non-Encumbrance Certificate, Building Plan and Building Completion Certificate.**

AND WHEREAS as per decision of WRC Show Cause Notice was issued to the institution on **27.02.2017**.

AND WHEREAS, the institution has not submitted reply of Show Cause Notice dt. 27.02.2017. The matter was considered by the WRC in its 311th meeting held on 25-27, September 2019 and the Committee decided as under: -


"The Show Cause Notice was issued to the institution vide letter dated 27/02/2017. The summary of the case submitted reveals that the institution has not submitted reply of the Show Cause Notice.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Western Regional Committee hereby withdraws recognition of **VITHOBAJI AMLE COLLEGE OF EDUCATION, WADSA ROAD, BRAHMAPURI, CHANDRAPUR, MAHARASHTRA-441206** granted for **B.Ed.** course on the grounds mentioned above from the end of the academic session next following the date of communication of the said order.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this Order. The guidelines for filing appeal may be seen on NCTE's website.
