WITHDRAWAL ORDER

WHEREAS, recognition was granted by the Western Regional Committee to the institution namely, **S.R. COLLEGE OF SCIENCE & TECHNOLOGY, VILLAGE CHAKARPUR, BLOCK NIWARI TIKAMGADH MADHYA PREDISH** vide Order No. WRC/5-6/100th/2008/30765-30770 dated 17.03.2008 for **B.P.Ed.** course of one year duration with an annual intake of one unit (s) of 50 students.

AND WHEREAS, the revised recognition order was issued to the institution namely **S.R. COLLEGE OF SCIENCE & TECHNOLOGY, VILLAGE CHAKARPUR, BLOCK NIWARI TIKAMGADH MADHYA PREDISH** vide order no. WRC/APW05511/224148/Revised Order{M.P.}/2015/135238-246 dt. 16.05.2015 for B.P.Ed. Programme of two years duration with an annual intake of 100 students from the academic session 2015-16 with certain conditions.

AND WHEREAS, the Institution has not submitted compliance of Revised Recognition Order. The matter was considered in WRC in its 255th meeting held on June, 22-24, 2016 and Committee decided to issued SCN on the following points.

1. Original Staff Profile (1- Principal/HOD+15- Faculties) from the session 2016-17 duly approved by the affiliating body.
2. Originally notarized (not xerox) CLU, NEC, Building Plan and Building Completion certificate.

AND WHEREAS, The SCN was issued to the Institution on 01.02.2017.

AND WHEREAS, The Institution has submitted reply of SCN vide letter dt. 01.03.2017.

AND WHEREAS, the matter was considered by the WRC in its 303rd meeting held on February 26-28, 2019 and the Committee decided as under:-

"The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made:-

- The institution is required to submit proof of additional built up area.
- The institution is required to submit proof of additional infrastructure.
- The institution is required to submit proof of additional Fund.
- The institution is required submit letter granting approval for the appointment of faculty by Affiliating University for B.P.Ed. course along with processing of selection committee and all related documents.
- The institution is required to submit Land Use Certificate issued by Competent Authority.
- The institution is required to submit NEC issued by Competent authority.
- The institution is required to submit building plan approved by the competent authority mentioning name of institution, course, khasra No/ Plot No., total land area, total built up area and earmarked area for each course being run in the same premises.
- The institution is required to submit Building Completion Certificate issued by competent authority.

Hence, show cause notice be issued under Section 17 of the NCTE Act, 1993 to the institution to submit reply within 30 days from the date of issue of show cause notice.

The request of the institution regarding reduction of intake from 100 to 50 in B.P.Ed. programme is not admissible as per NCTE Regulations. 2014."

AND WHEREAS, Accordingly, Show Cause Notice was issued to the institution dt. 12.03.2019.

AND WHEREAS, the institution has not submitted reply of Show Cause Notice, the matter was considered by the WRC in its 307th meeting held on May 30-31, 2019 and the Committee decided as under:-

"The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

- *The Show Cause Notice was issued to the institution vide letter dated 12/03/2019. The institution has not submitted reply of Show Cause Notice.*

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.P.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Western Regional Committee now hereby withdraws recognition of **S.R. COLLEGE OF SCIENCE & TECHNOLOGY, VILLAGE CHAKARPUR, BLOCK NIWARI TIKAMGADH MADHYA PRADESH** granted for **B.P.Ed.** course on the grounds mentioned above from the end of the academic session next following the date of communication of the said order.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this Order. The guidelines for filing appeal may be seen on NCTE's website.
