### CONTINUED ORDER

WHEREAS, recognition was granted to the institution namely, ANJUMAN COLLEGE OF EDUCATION, RUN BY ANJUMAN TAKNIKI ALAPSHANKHAYAK SHIRSHA PRASAR SAMITL 69/MIN2. 2. VILLAGE/STREET-CHAROKHARA, P.O. 70/MIN BHAGUAPURA, TEH/ TALKUA - SEONDHA, TOWN/CITY/DISTRICT- DATIA, MADHYA PRADESH under section 14(1) of the NCTE Act, 1993 for conducting B.ED. course of two year duration annual intake of 50 (one basic Units) WRC/APP3293/223/254 2016/169654-169661 dated 20.06.2016. students vide order NE

AND WHEREAS, the aforesaid letter was placed before WRC in the 281" meeting held on eptember 19-20, 2017 and it was decided as follows

"In order to systematize the compilation of complete information of all TEPs in the country, the NCTE HQrs New Delhi has asked all insolution to submit the Mandatory Affidavit on the prescribed format. The first such public Notice was issued on 05.10.2016. Further opportunity was given on 16.06.2017, and the last date for submission was 12.09.2017. NCTE Delhi also issued show Cause Notice through Public Notice to submit the Mandatory Affidavit within the specified date. Then, it compiled the list of institution and identified TEIs which has not complied with the submission of Mandatory Affidavit.

Thereafter, the WRC decided to issue Show Cause Notice institution on 23.09.2017 u/s 17 of the NCTE Act for non-compliance of the directions of the NCTE, and why the institution should not be derecognized. The reply should be sent on or before 23rd October 2017 after which further necessary action will be taken as per the Regulation."

AND WHEREAS, the show cause Notice (MAS) was issued to the institution on 23.09.2017 and the reply was not received to till date.

AND WHEREAS, Reminder letter-1 was sent to the Chairman, National Commission for Minority Education Institutions, New Delhi on 30.01.2018 regarding verification of Minority Certificate and the reply received on 13.03.2018

AND WHEREAS, the matter was placed in 290th Meeting held on March on 21-23, 2018 and the Committee decided that " The case file was seen. Recognition was granted for one unit of B.Ed. course vide order dated 20.06.2016 on the basis of the minority certificate. Subsequently, the minority certificate was sent to the National Commission for minority Educational institutions, New Delhi and the Commission vide letter dated 07.03.2018 has informed that the Commission has not issued Minority Certificate to the institution.

#### Hence, Show Cause Notice be issued as to why recognition should not be withdrawn. Reply should be submitted within one month.

AND WHEREAS, the show Cause Notice was issued to the institution on 27.03.2018 and the reply was not received to till date.

AND WHEREAS, the matter was placed in 293th Meeting held on June on 12-14, 2018 and the Committee decided that " The case file was seen. The Minority Certificate produced by the institution was sent to the National Commission for Minority Educational institutions, New Delhi for validation. The Commission vide letter dated 07.03.2018 has informed that it had not issued the Minority Certificate to the institution under case No. 1276 of 2016. Show Cause Notice was issued to the institution on 26.03.2018 and reply has not been received so far.

Hence, Recognition is withdrawn from the session 2018-19.

## FDRs, if any, be returned

AND WHEREAS, the Withdrawal was issued to the institution on 18.06.2018.

**AND WHEREAS**, the matter was placed in 294<sup>th</sup> Meeting held on July on 04-05, 2018 and the Committee decided that :- "The Decision taken in code No. APP3293 & APP3287 at S. No. 79 may be read as " Minority Certificate to the institution under case No. 4563 of 2015" instead of "The Minority Certificate to the institution under Case No. 1276 of 2016"

**AND WHEREAS**, the institution has filed an appeal to NCTE, Hqrs on 05.09.2018, "The Appellate Authority vide its appealed order dat. 15.05.2019 remand back the case to the WRC, NCTE for necessary action.

**AND WHEREAS**, the matter was placed in 309<sup>th</sup> Meeting held on July on 23<sup>rd</sup> -26<sup>th</sup>, 2019 and the Committee decided that :- "The Committee considered case appeal order dated 15.05.2019. The institution needs to submit certified copy of minority certificate issued by the competent authority withing 30 days to process the case further.

**AND WHEREAS**, the institution Reply received Minority Certificate. It is stated that the certified copy of order is issued by the Commission and the institution has been granted Minority Status Certificate on 08.12.2016 in case No. 1276 of 2016.

**AND WHEREAS**, the matter was placed in 316<sup>th</sup> Meeting of WRC held on 27<sup>th</sup> to 28<sup>th</sup> August & 04 September 2020 and the Committee decided that:- "*The WRC examined the issue in detail and noted that the institution in response to SCN had submitted the copy of Certificate dated 08<sup>th</sup> December 2016 along with the minutes dated 05<sup>th</sup> December 2016.* 

The NCMEI vide letter dated 07.03.2018 received on 13.03.2018 had stated that the above certified has not been issued by the NCMEI.

The institution vide representation dated 13.09.2019 had submitted the copy of certificate duly certified by Secretary, NCMEI on 11.09.2019.

The WRC observed that on the one hand the NCMEI has mentioned that the certificate has not been issued by them, whereas on the other hand, they have issued a Certified copy of the same on 11,09,2019.

In view of the above fact, the WRC decided that the certified copy submitted by the institution be forwarded to Minority Commission for their comments."

AND WHEREAS, the institution Reply received NCMEI Vide letter dated 23.09.2020 received in WRO on 06.10.2020.

**AND WHEREAS,** the Matter was considered by WRC in its 321<sup>st</sup> Meeting held on 09<sup>th</sup> and 11<sup>th</sup> November 2020 and WRC decided (Ref: SI. No. 30, Page No. 28 of 321<sup>th</sup> WRC Minutes) as under:

"The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee decided as under"
