## ORDER

WHEREAS, the institution was granted recognition for B.Ed. course of 02 years duration with an annual intake of 100 students (Two Units of 50 Students each) from the academic session 2017-2018 vide Ordet No. WRC/APP201660250/223/ID No. 11253/275ttv 185484-491 dated 05.05.2017 and D.El.Ed. course of 02 years duration with an annual intakel of 100 students (Two Units of 50 Students each) from the academic session 2017-2018 vide order no. WRC/NCTF/APP201660248/11252 /275th/D.El.Ed./134661 to 184868 dated 04.05.2017

AND WHEREAS, complaint dated 24.05.2017 received against the institution for D.EL.Fa. course (APP201660248) was considered by WRC in its 276th meeting held on 3 Ma to 31st May, 2017 and Committee decided that till the enquiry is completed and reports submitted, no admission shall be made in both B.Ed. and D.El.Ed. courses. The affiliating bodies be informed accordingly. Accordingly, decision taken by WRC was commutated to art concerned as meathered when on USON 2017 followed by Rennada settle collections 19.07.2017:

AND WHEREAS, confirmation was sought from National Commission for Minority Educational Institutions, New Delhi vide WRC letter dated 09.08.2017 and reply received vide their letter dated 19.09.2017, wherein no confirmation was received for this institution regarding its minority status.

In response to complaint received on 24.05.2017, the case was referred to the Collector/SDM, Chhatarpur. Since there were two conflicting reports from the same SDM, both the reports were referred to the Collector/SDM. The SDM, Chhatarpur had confirmed that the first report dated 13.06.2017 should be considered as the valid report. This report was considered by WRC in its 282nd meeting held on 24th to 26th October, 2017. Since, this report is negative with regard to documents, infrastructure etc., as decided by the Committee, recognition for B.Ed. and D.El.Ed. courses were withdrawn with immediate effect vide order dated 01.11.2017 and 09.11.2017 respectively. Being aggrieved, this institution had preferred an appeal on 12.01.2023 for D.El.Ed. course only after a delay of over 05 years and Appellate Authority decided to reject the appeal and confirmed the decision taken for withdrawal by WRC vide Order File No. 89-22/E-288118/2023 Appeal/1st Meeting 2023 APPLWRC20314532 dated 09.02.2023 for D.El.Ed. course on the grounds mentioned therein.

AND WHEREAS, WRC in its 399th meeting held on 09th to 10th January. 2024 had considered the Agenda Note prepared and placed before the WRC. Wherein it has been mentioned that the case was remanded back by the Appeal Committee vide order dated 09/02/2023 along with documents submitted by the institution vide their letter dated 29/12/2023. Considering the agenda placed in the meeting, the Committee decided as under:-

- (a) The recognition of the institution for B.Ed. and D.El.Ed. Course be restored.
- (b) The WRC further decided that the show cause notice under section 17 of NCTE Act, 1993 be issued to the institution to submit reply within 15 days from date of issue of show cause notice on the following grounds:
  - (i) The latest faculty list duly approved by the affiliating body be submitted.
  - (ii) Copy of Minority Certificate is to be submitted.
  - (iii) The copy of letter issued by SDM as stated in the letter be submitted.

AND WHEREAS, above decision taken by WRC was implemented and Restoration of recognition order was communicated to institution and all concerned vide Order No.WRC/APP201660250-B.Ed./M.P./399th/Meeting/2024/224715-7122 dated 16.01.2024 in respect of B.Ed. course and in respect of D.El.Ed. course vide Order No.NCTE/WRC/APP201660248-D.El.Ed./M.P./399<sup>th</sup> Meeting/2024/224723-30 dated 16.01.2024 respectively. In addition, Show Cause Notice u/S 17 of NCTE Act, 1993 was issued to the institution vide letter No.NCTE/WRC/APP201660248-D.El.Ed., APP20160250-B.Ed./399th Meeting/2024/224846-47

dated 31.01.2024 on the grounds mentioned therein. Reply of Show Cause Notice u/S 17 was received in WRC office on 22.02.2024. Meanwhile, based on the facts/ documents as well as allegations through complaint against wrongly issuance of Restoration Order for B.Ed. and D.El.Ed. courses pertaining to institution which is inquired by the Vigilance Division, an Office Memorandum vide No. NCTE-Vign013/5/2024-Vigilance Section-HQ dt. 06th November, 2024 was received from Vigilance Division, NCTE Hqrs. wherein it has been requested to review the restoration Orders dated 16.01.2024 and withdraw the recognition for B.Ed. and D.El.Ed. courses of Guru Hargovind Singh Shiksha Mahavidhyalaya, run by Khalsa Minority Trust, Chhatarpur, Madhya Pradesh as deemed appropriate.

AND WHEREAS, after consideration of brief chronological facts related with the case, the matter was considered by WRC in its 408<sup>th</sup> (Part-2) Meeting held on 25<sup>th</sup> to 26<sup>th</sup> November, 2024 and the Committee observed as under:

As per the direction and discretion of Vigilance Division, NCTE HQrs., the Committee reviewed its decision taken in 399th Meeting of WRC held on 9th -10th January 2024, and observed that the institution was wrongly restored the recognition of B.Ed. & D.El.Ed. courses.

## AND WHEREAS the Committee unanimously decided that:

- 1. "On re-verification of office records and alleged irregularities found in the Agenda Note on the basis of facts referred by Vigilance Division, NCTE, the Committee decided that the recognition of both B.Ed and D.El.Ed. courses restored in 399th Meeting vide Order No.WRC/APP201660250-B.Ed./M.P./399th/Meeting/2024/ 224715-7122 dated 16.01.2024 and Order No.NCTE/WRC/APP201660248-D.El.Ed./ M.P./399thMeeting /2024/224723-30 dated 16.01.2024 respectively are hereby decided as cancelled and treated as null and void under intimation to all concerned with specific instruction to concerned Affiliating Bodies to cancel the affiliation of both B.Ed. and D.El.Ed. courses. In case, any admission taken by the institution, the admitted students shall be accommodated in other recognized institution under the jurisdiction of same affiliating body with an intimation to WRC, NCTE.
- 2. In the light of present decision of the Committee, Withdrawal Order issued vide Order No. WRC/APP201660250/223/282nd /2017/192336 dated 01.11.2017 for B.Ed. course and Withdrawal Order issued vide No. WRC/APP201660248/11252/222/ 282nd/ M.P./2017/192626 dated 09.11.2017 for D.El.Ed. course respectively shall remain unchanged and decision taken by WRC in pursuance of its 399th Meeting for restoration of recognition for B.Ed. and D.El.Ed. course is hereby decided as null and void. Accordingly, decision be communicated to all concerned.
