

FINAL SHOW COUSE NOTICE

The recognition was granted to the institution namely **ADARSH SHIKSHA MAHAVIDYALAYA, (RUN BY SOCIETY FOR THE WELFARE OF ADIWASI REGION), HALKA NO.8, KHATA NO.71, SURVEY NO. 436, THANDLA, JHABUA-457777, MADHYA PRADESH** vide Order no. WRC/5-6/APW06519/222420/124th/2009/59769 dt. 26.08.2009 for **D.Ed.** course of two (2) years duration with an annual intake of 50 students.

AND WHEREAS, the institution applied under clause 8(9) of NCTE Regulations 2014, for change of premises of D.Ed. course from **ADARSH SHIKSHA MAHAVIDYALAYA, (RUN BY SOCIETY FOR THE WELFARE OF ADIWASI REGION), HALKA NO.8, KHATA NO.71, SURVEY NO. 436, THANDLA, JHABUA-457777, MADHYA PRADESH** to **ADARSH SHIKSHA MAHAVIDYALAYA, RUN BY SOCIETY FOR THE WELFARE OF ADIWASI REGION, PLOT NO.1, 2, SURVEY NO.53/1, 55/1, SOYAT KHURD TO MODI ROAD, VILLAGE/TOWN/CITY RAMGARH, JEERAPUR, DISTRICT RAJGARH, MADHYA PRADESH.**

AND WHEREAS, the visiting team constituted by the WRC inspected the new premises on 30.11.2015.

AND WHEREAS, the visiting team report alongwith other documents, videography was placed before the WRC in its 238th meeting held on January 01-02, 2016. The committee decided as under:-
"...The committee perusal the report submitted by the Visiting Team and viewed the CD to have the status of the building. The institute has good building and required infrastructural facility. The VT has recommended the case. **Hence, the shifting is permitted.**" Accordingly, letter was issued on 05.01.2016

AND WHEREAS, the WRC in its 297th meeting held on September 13-14, 2018. The committee decided as under:-

"The institution has applied for shifting on 05.09.2018. An examination of the file shows that the institution has not submitted detailed Building plan, Building Completion Certificate and non-encumbrance certificate. The institution should also submit a list of current staff duly approved by the Registrar for B.Ed. course and by the Rajya Shiksha Kendra for D.El.Ed. course. **Compliance should be submitted by the institution within one month.**" Accordingly, Compliance letter was issued on 19.09.2018 & the reply received from the institution dt. 05.10.2018.

AND WHEREAS, the institution applied for change of premises of D.Ed. course from **ADARSH SHIKSHA MAHAVIDYALAYA, RUN BY SOCIETY FOR THE WELFARE OF ADIWASI REGION, PLOT NO.1, 2, SURVEY NO.53/1, 55/1, SOYAT KHURD TO MODI ROAD, VILLAGE/TOWN/CITY RAMGARH, JEERAPUR, DISTRICT RAJGARH, MADHYA PRADESH** to **ADARSH SHIKSHA MAHAVIDYALAYA, RUN BY SOCIETY FOR THE WELFARE OF ADIWASI REGION, P.H. NO. 78 SURVEY NO. 235/1/2, VILLAGE-KHEJDIYA, TEHSIL- JEERAPUR, DESTRICT- RAJGARH MADHYA PRADESH.** The matter was considered by WRC in its 314th meeting held on July 13th to 15th & 22nd, 2020 and committee decided as under: -

"This is a case of shifting. Shifting was allowed on 05.01.2016. Thereafter the WRC in its 297th meeting clubbed the B.Ed. and D.Ed. programme and decided to issue Show Cause Notice seeking certain documents.

The Committee considered the reply to SCN dated 05.10.2018 and 31.10.2019 of the institution and observed that the institution has not submitted the following documents:-

- **Non Encumbrance Certificate**
- **Original Staff List**

In view of the above, the Committee decided that last opportunity be given to the institution to reply within 30 days u/s 17 of the NCTE Act."

NOW THEREFORE, this Show Cause Notice is issued to the institution U/S 17 of NCTE, Act, 1993 giving an opportunity for making written representation within 30 days of the date of issue of this notice. In the event of this office not receiving any representation within a laid down period of the date of issue of this notice, it will be presumed that you do not wish to make any representation and the Western Regional Committee shall take the decision, as it deems fit and proper.
