SHOW CAUSE NOTICE

The case of SHRI NITYANAND B.ED COLLEGE, HALKA NO - 14, SURVEY NO -365, GRAM- GYANPURA, VIKASKHAND-TIRLA, DHAR, MADHYA PRADESH to consider compliance of Revised Order Regulations 2014 for B.ED. course was considered by WRC in its **315th Meeting held on 10th to 11th & 14th August 2020** and WRC decided (Ref: Sl. No. 30, Page No. 21 of 315th WRC Minutes) as under:-

"This is a RPRO case and same was remanded back through Court with a direction to call the petitioner for personal hearing.

The personal hearing of the institution was held on 26th February 2020, wherein it was decided that the representative of the institution will submit the required documents today itself.

The WRC examined the documents submitted by the institution and observed the following deficiencies:-

- The Building plan is not approved by Government Engineer.
- The faculty at Sr. No. 02 is not qualified as per NCTE norms as he does not possess required 55 % marks in PG.

In view of the above, the Committee decided that last opportunity be given to the institution to reply within 30 days u/s 17 of the NCTE Act."

Now therefore, this Show Cause Notice is issued to the institution u/s 17 of NCTE, Act, 1993 giving an opportunity for making written representation within 30 days of the date of issue of this notice. In the event of this office not receiving any representation within a laid down period of the date of issue of this notice, it will be presumed that you do not wish to make any representation and the Western Regional Committee shall take the decision, as it deems fit and proper.
