

SHOW CAUSE NOTICE

WHEREAS, recognition was granted to the institution namely **RAJEEV GANDHI COLLEGE, E-8 TRILANGA, BHOPAL 462039 MADHYA PRADESH** vide Order No.WRC/5-6/9nd/2006/3787 dated 05.01.2007 for **M.Ed.** course of one (1) year duration with an annual intake of one unit (s) of 25 student and vide order no WRC/5-6/ 92rd/2007/026734 dt. 16.01.2008 enhance the intake for the M.Ed. programme 25 to 40 students.

AND WHEREAS, the revised recognition order was issued to the institution namely **RAJEEV GANDHI COLLEGE, E-8 TRILANGA, BHOPAL 462039 MADHYA PRADESH** vide order no. WRC/APW03680/225024/{M.P.}/2015/146848 dt.31.05.2015 for M.Ed. programme of two years duration with an annual intake of 50 students from the academic session 2015-16.

AND WHEREAS the matter was Considered by WRC in its **304th** meeting held on 02nd to 04th April 2019 of WRC and the Committee decided that:

"The original file of the Institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

The revised recognition order was issued to the institution on 31/05/2015. The institution has submitted reply dated 11/01/2016 & 29/02/2016 received in the office of WRC on 13/01/2016 & 29/02/2016. On perusal of the reply of the institution it is observed that the institution has not submitted the following documents:


- The institution has not submitted any proof of additional built up area.
- The institution has not submitted any proof of additional infrastructure.
- The institution has submitted a letter date 29/02/2016 issued by Baraktullah University along with staff list signed by Registrar, Baraktullah University. As per List S. NO. 2 Dr. Ranjana Agrawal, Professor not approved.
- The institution has not submitted BCC issued by the competent authority.
- The institution has not submitted certified registered land document.
- The recognition for B.Ed. course has already been withdrawn as per decision of WRC in its 301st meeting conveyed vide order dated 25/01/2019.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for M.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

AND WHEREAS, Withdrawal order issue to the institution on dt. 12.04.2019.

AND WHEREAS, the Hon'ble High Court of Delhi at New Delhi, and the institution has file W.P. 5035/2019 Court order dated 13.05.2019.

AND WHEREAS the matter was Considered by WRC in its **307th** meeting held on 30th to 31th May 2019 of WRC and the Committee decided that:-

"In view of the direction of the Hon'ble High Court of Delhi in W.P.(C) 5035/2019 & CM APPLs 22268/2019, 22269/2019 order dated 13/05/2019 at point No. 08, decision of WRC about the withdrawal order stayed and website be updated accordingly. "

AND WHEREAS, the Hon'ble High Court of Delhi at New Delhi, and the institution has file W.P. 5035/2019 & CM APPL.22269/2019 Court order dated 26.11.2019.

AND WHEREAS the matter was Considered by WRC in its **312th** meeting held on 27th to 29th January 2020 of WRC and the Committee decided that:

"The Committee studied the decision of the Hon'ble High Court in the W.P. No. 5035/2019. The Committee decided that the representative of the institution be given personal hearing in the next meeting of WRC. The date of the personal hearing will be intimated later.

The representative along with the requisite documents be remain present."

AND WHEREAS, the matter was Considered by WRC in its **313th** meeting held on 25th to 27th February 2020 of WRC and the Committee decided that:

"As per the decision of WRC in its 312th meeting in compliance of the Court directions, the representatives of the institution appeared before WRC for personal hearing on 26/02/2020. It is decided after the discussion that the representative of the institution will submit the required documents today itself."

AND WHEREAS, the institution has submitted reply vide letter dt.26.02.2020 received in WRO on 27.02.2020.

AND WHEREAS, the matter was placed in **315th** Meeting held on August 10th to 11th and 14th August 2020 of WRC and the Committee decided that:-

"This is a RPRO case and same was remanded back through Court with a direction to call the petitioner for personal hearing.

The personal hearing of the institution was held on 26th February 2020, wherein it was decided that the representative of the institution will submit the required documents to WRC Office today itself. The institution had submitted the documents to WRC on 27th Feb 2020.

"The WRC examined the documents submitted by the institution and observed the following deficiencies:-

- **The Built up area in the institution is less than the required for all the running teacher education programmes.**
- **The institution is required to submit the demarcated site plan, duly approved by the competent authority, mentioning the land and built up area for all the courses being run in the institution.**
- **Original FDRs for Rs. 12 lakhs towards Endowment and Reserve Fund not submitted.**

In view of the above, the Committee decided that last opportunity be given to the institution to reply within 30 days u/s 17 of the NCTE Act."



NOW THEREFORE, the institution is required to submit compliance accompanied with an affidavit from the authorized compliance of the Management. The compliance along with an affidavit must reach this office within 30 days of the issue of this Notice. In case, the office does not receive any compliance within stipulated time, it will be presumed that the institution does not wish to make any compliance, and the Western Regional Committee shall take decision as per provisions of the NCTE Act, Rules and Regulations.
