**SHOW CAUSE NOTICE**

WHEREAS, WRC-NCTE had granted permission to the institution namely **YUVA RASHTRASANT BHAYYUJI MAHARAJ B.ED. COLLEGE, BIRSA MUNDA ADIWASI BAHUUDSHIYA, SHIKSHAN SANSTHAS, VIJAY NAGAR, BOTHA ROAD, SUNDERKHED, BULDHANA, MAHARASHTRA** vide order No. WRC/5-6/89/2006/ dated: 27.9.2006 for conducting **B.Ed.** course with an annual intake of 100 in a rented premises with a condition to shift to its own premises within three years of such recognition.

2. The matter was considered by WRC in its **316<sup>th</sup> meeting** of WRC held on **27<sup>th</sup> – 28<sup>th</sup> August and 4<sup>th</sup> September 2020** wherein the committee decided as under: -

*The WRC considered the entire issue in detail and noted that as per NCTE Regulations dated 13.11.2002. Initially institutions were permitted to start the course in a rented-premises with a condition to shift to their own premises within a period of three years from the date of such recognition.*

*From the Agenda note placed before WRC, it is observed that many institutions have not yet shifted to their own premises neither they have applied to WRC for shifting of premises of their institutions.*

***The WRC considered the entire issue in detail and decided that Show Cause Notice u/s 17 of the NCTE Act be issued to reply within 30 days to all such institutions which have been permitted or given recognition / permission to run the programme in rented premises and have not yet applied for shifting of their institution.***

***Further, the WRC also decided that the applications of the institutions who have applied for shifting of premises be examined by office at the earliest and placed before WRC for consideration and decision.***

3. Accordingly, as per the decision of WRC, you are hereby served this SHOW CAUSE NOTICE under Section 17 (1) of the NCTE Act, as to why recognition granted to your institution should not be withdrawn. Your written representation along with supporting documents and Affidavit should reach this office within 30 days from the date of this NOTICE.



4. In case the reply submitted is incomplete or factually incorrect or not received in this office within 30 days of the date of this Notice, then it shall be treated as incomplete reply to the terms of this notice and action as deemed appropriate as per NCTE, Act, Rules and Regulations shall be taken.

5. Your reply shall reach this office within stipulated time through Courier/Registered AD/Speed post only. Applicants are not required to personally visit the RC Office for any reason whatsoever.
