The case of SARDAR PATEL COLLEGE OF TECHNOLOGY, VINDHYA EDUCATION SOCIETY, POLYTECHNIC COLLEGE ROAD, GAYKHURI ROAD, BALAGHAT, MADHYA PRADESH to consider compliance of Revised Order Regulations 2014 for B.ED. course was considered by WRC in its 315th Meeting held on 10th to 11th & 14th August 2020 and WRC decided (Ref: Sl. No. 36, Page No. 24-25 of 315th WRC Minutes) as under:-

"This is a RPRO case and same was remanded back through Court with a direction to call the petitioner for personal hearing.

The personal hearing of the institution was held on 22<sup>nd</sup> July 2020, wherein the petitioner informed that it had submitted certain documents to WRC Office.

The WRC examined the documents submitted by the institution and observed the following deficiencies:-

 The percentage of marks obtained in respect of staff appointed has not been mentioned.

In view of the above, the Committee decided that last opportunity be given to the institution to reply within 30 days u/s 17 of the NCTE Act."

Now therefore, this Show Cause Notice is issued to the institution u/s 17 of NCTE, Act, 1993 giving an opportunity for making written representation within 30 days of the date of issue of this notice. In the event of this office not receiving any representation within a laid down period of the date of issue of this notice, it will be presumed that you do not wish to make any representation and the Western Regional Committee shall take the decision, as it deems fit and proper.
