SHOW CAUSE NOTICE

WHEREAS, WRC-NCTE had granted permission to the institution namely COLLEGE OF EDUCATION, COJYA SANE GURUJI VIDHYA PRASARAK MANDAL, PLOT & KHASRA No. 212,213, VILLAGE-OHIDE (TARFE HAVELI), TAL. SHAHABA, DISTRICT – NANDURBAR, MAHARASHTRA vide order 25.08.2009. with an annual intake of 25 students. Further additional intake of 10 students was granted vide order by WRC/APW06773/125114/113006/140/2010/73804-73809 dt. 14.01.2011, thereby making the total intake of the stitution to 35 students for conducting M.Ed. (M) (Co.Ed.) course.

As the institution has not submitted an Affidavit for their willingness to adhere to the provisions NCTE egulations 2014 and accordingly revised recognition orders for two years M.Ed. course have not been issued to the stitution.

The matter was considered by WRC in its 314th meeting of WRC held on 13th - 15th and 22nd July 2020 wherein the committee decided as under:-

The WRC noted that this institution had not submitted an Affidavit conveying its willingness to come under NCTE Regulations 2014 and the revised Recognition order was not issued on the institution.

As on date, it is not clear whether the institution is running the one-year M.Ed. programme or got affiliation for two years from the University without issuance of revised recognition order from NCTE.

In view of the above, the Committee decided that Show Cause Notice be given to the institution to reply within 30 days u/s 17 of the NCTE Act.

4. In compliance of the decision of the WRC, the Show Cause Notice is issued to the institution under Section 17(1) of the NCTE Act, 1993. The institution is directed to submit written representation within a period of 30 days from the date of this Notice. In the event, this office does not receive ant reply, it will be presumed that the institution has nothing to say and the Regional Committee shall take action for withdrawal of recognition
