**AND WHEREAS**, the revised recognition order was issued to **Maa Kaila Devi College of Education, Run By Shri Nakoda Shiksha Samiti, Plot No.24, Khasra No. 93 Min & 89/4 Min, Village-Naugaon, Pargana Gwalior, Shivpuri Link Road, Gwalior-474001, Madhya Pradesh** vide order No. WRC/APW01702/223392/2015/148181,188,189,191,192,193,195,196,198 dt. 31.05.2015 for B.Ed. Course of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16.

**AND WHEREAS**, the letter for Affidavit Regarding Acceptance and Compliance of NCTE Regulation, 2014 was issued to the institution on 19.01.2015 and the reply was received on 30.12.2014

**AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the WRC in its 255<sup>th</sup> meeting held on 22-24 June, 2016 and the Committee decided "...issued Show Cause Notice to the institution of the condition maintained in revise order"

**AND WHEREAS**, a Show cause notice was issued to the institution on 08.09.2016 for not submitting compliance of Regulation 2014 required faculty staff list for two units and infrastructure the institution reply was submitted on dated 27.09.2016.

**AND WHEREAS**, the matter was placed in 285<sup>th</sup> Meeting held on December 19-20, 2017 and the Committee decided that "In response to the Cause Notice dated 27.07.2016,

The case file was seen. In response to the Show Cause Notice dated 08.09.2016, the institution has not submitted approved staff profile.

Building Completion Certificate not submitted in the prescribed format.

FDRs of Rs.12.00 lakhs submitted but not in joint name.

**Hence, Recognition is withdrawn. From the academic session 2018-2019, FDRs if any, be returned"**

**AND WHEREAS**, the Withdrawal order was issued to the institution on 08.01.2018 for Recognition is withdrawn from the session 2018-19.

**AND WHEREAS**, the institution has filed an appeal to NCTE, Hqrs on 08.02.2018, "The Appellate Authority vide its appealed order dat. 06.06.2018 remand back the case to the WRC, NCTE.
