REFUSAL ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993 Shiv Shankar Seva Sansthan, Naya Tila, Post – Borkhadi Kalan, Tehsil – Pipalu, District – Tonk - 304506 Rajasthan had submitted an application to the Northern Regional Committee of NCTE on 27.10.2008 for grant of recognition to Yash Mohan Teacher Training College, Plot/K.no. 1392 Village/Town/City – Sohela, Stree/Road – Near ITO office, Tehsil – Pipalu, District – Tonk – 304021, Rajasthan for B.Ed. Course of two years duration.

AND WHEREAS, the matter was placed before NRC in its 295th meeting held from 06^{to} to 11th February, 2019 and the Committee observed as under:-

In view of letter No. F.67/19/2018-US(Legal)-Hq. dated 18.12.2018 of NCTE Hqrs. directing to ensure compliance of the orders of the Hon'ble Apex Court in SLP No. 4247-4248/2009 dated 10.09.2013 and in W.P.(C) No. 276/2012 dated 18.07.2018 and of the Hon'ble High Court of Delhi in LPA No. 619/2018 dated 31.10.2018 and adhere to the provision of clauses 5(3), 7(4), 7(5) and 7(6) of the NCTE Regulations, 2014, the Committee decided that as per provision of Regulation 7(4) of National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2014, a letter be sent to the State Government to obtain its recommendation/comments on the proposal made by the institution.

NCTE further decided to issue Show Cause Notice on the following grounds :-

1. The proposal of the affiliating body has not been submitted.

2. The institution has not submitted any proof/ evidence to prove that it is a composite institution as per clause 2(b) of NCTE Regulations, 2014.

3. The land was registered after the date of submission of application.

4. The institution has not submitted Non-encumbrance Certificate signed by the Competent Govt. Authority.

5. The institution has not submitted the approved Building plan signed by the Competent Govt. Authority indicating the name of the course, address of the institution, Khasra No./Plot No., total land area, total built-up area and the measurements of the Multi-purpose Hall as well as the other infrastructural facilities such as class rooms etc.

6. The institution has not submitted the Notarized copy of Change of Land use Certificate issued by the Competent Govt. Authority."

AND WHEREAS a Show Cause Notice was issued on 01.03.2019 to the institution.

AND WHEREAS the institution submitted reply of Show Cause Notice received in the office of NRC on 02.03.2019.

AND WHEREAS the matter was considered by NRC in its 310th meeting held from 20th to 22nd November, 2019 and the Committee observed as under:-

1. All these cases were considered by NRC and processed in compliance to the court direction and considering the reply submitted by the institution against the Show Cause Notice.
2. The NCTE Hqrs. Vide letter No. F. 67/19/2018-US(Legal)-HQ dated 18.12.2018 has directed to ensure compliance of the orders of the Hon'ble Apex Court and High Court of Delhi, referred in their letter, and adhere to the provision of Regulations 5(3), 7(4), 7(5) and 7(6) of NCTE Regulations, 2014 irrespective of its stage of processing of application, course, year of application and State to it pertains.
3. In view of the above, the recommendations were sought from the state government which refused permission to start the courses vide and office order No. एफ)24recmmd.17-18)बीएड/आकाशि/16/182/दिनाँक 09.4.2019 and office order No. एफ)24अनुशंसा/बी.एड/आकाशि/19/511, 512, 513, दिनाँक 11.11.2019
4. Further, a number of deficiencies as mentioned below were also noted in this case and hence permission cannot be granted by NRC for starting the B.Ed. course :-
 1. The institution has not submitted any proof / evidence to prove that it is a composite institution as per clause 2(b) of NCTE Regulations, 2014.
 2. The land was registered after the date of submission of application.
 3. The institution has not submitted the Notarized copy of Change of Land use Certificate issued by the Competent Govt. Authority.
 4. Certificate from the relevant department of the government certifying that the society is not for profit/Charitable Trust/Society/Company is not submitted.
 5. A copy of Mutation Certificate issued by the competent authority is not submitted.
 6. Site Plan showing the location of the building as per the land & revenue records of the concerned authority not legible
 7. Building Safety Certificate issued by the competent authority not submitted
 8. Fire Safety Certificate issued by the competent authority not submitted.
 9. A certificate to the effect that the institutional campus, building furniture is disabled friendly as per the persons with disability (PWD) and of the Government of India not submitted.

AND WHEREAS as per NCTE (Recognition Norms and Procedure) Regulations, 2014 Clause 7(11), in the matter of grant of recognition the Regional Committees shall strictly act within the ambit of the Act, the regulations made thereunder including the norms and standards for various teacher education programmes and shall not make any relaxation thereto.

Accordingly, the Committee decided that the application is rejected and order be issued accordingly, on case to case basis.


