**Final Show Cause Notice**

**WHEREAS**, In terms of Section 14(1)/Section 15(1) of the NCTE Act, 1993, **Shri Ram College Run by Shri Darbarilal Sewa Samiti, Plot no. 90/1/1KH/1, Village – Mungwara, P.O. – Gulabganj, Tehsil – Gyaspur, District – Vidisha – 464001, Madhya Pradesh** has submitted an application (Code No.-APP3069 & APP2319) to the Western Regional Committee of NCTE for grant of recognition /permission for conducting **B.Ed. course** with an annual intake of 100 students on 02.03.2014 and in the light of NCTE Regulations, 2014, Revised Recognition Order was issued to the institution vide Order No. WRC/APP2319/223/2015/ 135853 dated 19.05.2015 for B.Ed. course with annual intake 100 Students (Two Basic Units of 50 Students Each) from the academic session 2015-2016 and **B.Sc. B.Ed. Integrated course of 4 (Four) duration** with an annual intake of 100 students (Two Basic Units of 50 Students Each) from the academic session 2016-2017 vide Order No. WRC/APP3069/B.Sc. B.Ed./245<sup>th</sup>/2016/162847 dated 03.09.2016.

2. **AND WHEREAS**, Show Cause Notice on Revised Recognition Order issued on 28.02.2017 to the institution. The institution has submitted reply of SCN on Revised Recognition Order vide their letter No.208/B.Ed./4/2017 dtd. 20.04.2017.

3. **AND WHEREAS**, the institution has submitted an application for change of name of the institution as “**Shri Ram College to Aryawarth Mahavidyalaya**” vide their letter No. SRC/91/24 dated 13.02.2024 received in WRC office on 22.02.2024. The matter was placed in its 408<sup>th</sup> WRC meeting held on 12<sup>th</sup> to 14<sup>th</sup> November, 2024 and the Committee decided the following:

The application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- NOC from concerned affiliating body / University as well State Govt. related to change of name of institution is required to submit by the institution.
- Individual affidavit of members of the society /trust on notarized Non-judicial stamp paper of Rs.10/- is required to submit by the institution.

In view of the above, the Committee decided that Clarification Letter be issued to the institution to submit reply supported with documents within 21 days from the date of issue of letter along with affidavit by the authorized representative of the management.

Accordingly, a Clarification letter issued to the institution on 13.12.2024.

4. **AND WHEREAS**, the institution has not submitted reply of letter dtd. 13.12.2024 so far. The institution filed W.P.(C) 3243/2025 High Court of Delhi at New Delhi. The Hon'ble High Court of Delhi passed an order dated 17.03.2025. The matter was placed in its 417<sup>th</sup> WRC meeting held on 07<sup>th</sup> to 10<sup>th</sup> April, 2025 and the Committee decided the following:

(1) The application of the institution for change of name dated 13.02.2024 received on 22.02.2024 along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time along with the direction given by the Hon'ble High Court of Delhi at New Delhi in Writ Petition(C) No.3243/2025 vide order dated 17.03.2025 and the Committee observed as under:

**(A) The Committee earlier considered the matter and as decided, letter dated 13.12.2024 was issued to the institution bearing Speed Post tracking Number: ED531139621IN seeking following documents:**

- (iii) NOC from concerned affiliating body / University as well as State Govt. related to change of name of institution is required to submit by the institution.
- (iv) Individual affidavit of members of the society /trust on notarized Non-judicial stamp paper of Rs.10/- is required to submit by the institution.

The institution did not submit reply thereon. Therefore, the Committee decided that second opportunity be given to the institution to submit their reply within 15 days from the date of issue of letter.

**(B) Further, the Committee decided to return Demand Draft No.000423 dtd. 03.02.2024 for Rs.1,77,000/- to the President of the Society of the Institution and same may be apprised to the Hon'ble High Court of Delhi at New Delhi.**

**(2) Further, the Committee considered the reply dated 20.04.2017 in response to first Show Cause Notice dated 28.02.2017 in pursuance of Revised Recognition Order for B.Ed. course of two years duration along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:**

**The institution is still deficient on the following:**

- (i) The institution is required to submit Certified Registered Land Documents issued by the Registering Authority.
- (ii) The institution is required to submit certified copy of Mutation of Land Certificate issued by the competent Govt. authority.
- (iii) The institution is required to submit Blue Print of approved Building Plan issued by the Competent Govt. Authority indicating the name of all courses, name of the institution, Khasra No./Plot No., total land area, total built-up area with the measurements of the Multi-purpose Hall as well as other infrastructural facilities such as class rooms etc. and earmarked land and built up area for each course being run in same premises.

- (iv) The institution is required to submit latest Non-Encumbrance Certificate issued by the Competent Government Authority indicating that the land is free from all encumbrances.
- (v) The institution is required to submit certified copy of Site Plan with demarcated land area for running different courses in the premises.
- (vi) The institution is required to submit Building Safety Certificate issued from the Competent Government Authority.
- (vii) The institution is required to submit Fire Safety Certificate issued by the Competent Government Authority for current year.
- (viii) The institution is required to submit Certificate to the effect that the building is differently abled friendly issued from the Competent Government Authority.
- (ix) The institution is required to submit Building Completion Certificate (17 points) in prescribed format signed by the Competent Government Authority which format is available on WRC's web portal.
- (x) The institution is required to submit latest approved appointed faculty/ies list for B.Ed. programme countersigned by the Registrar of the concerned university in the prescribed format available at WRC's official web-site as per provision of Clause-5 of Appendix-4 of NCTE Regulation, 2014 as well as point No. 8 of GOI No. 237 dated 09.06.2017.
- (xi) The institution is required to submit photocopies of valid Fixed Deposit Receipts issued from Nationalized/ Scheduled Bank towards Endowment & Reserve Fund in the joint operation mode with Regional Director, WRC, NCTE & Management along with duly filled Bank Form "A" in original, verified/signed by the Manager of the Bank as per NCTE Regulations, 2014.
- (xii) The institution is required to submit information of downloaded copies of documents from the website of the institution with hyperlinks of the same as per provisions of 7(14)(i) of the NCTE Regulations, 2014 as amended from time to time.

**In view of the above, the Committee decided that Final Show Cause Notice be issued to the institution for B.Ed. programme to submit reply within 15 days from the date of issue of letter.**

5. Your reply, complete in all respects must reach in this office within 15 days from the date of issue of this Final Show Cause Notice, failing which WRC will take the decision as deemed fit as per the provisions contained in the NCTE Act, Rules and Regulations.

6. In view of the above decision it is expected that your reply shall reach this office through Courier/Registered AD/ Speed Post only. NCTE does not expect applicants to personally visit the RC Office for any reason whatsoever.
