WHEREAS recognition was granted to the institution namely "Harman Dass Lekhraj Institute of Education," Chak 24 B.B. Killa No. 18,23 Ganjsinghpur, Sriganganagar- 335041, Rajasthan for B.Ed. course of one year duration with an annual intake of 100 students vide order No. F.NRC/NCTE/RJ-1593/2008/59024-30 dated 26.08.2008 from the academic session 2008-2009.

2. AND WHEREAS, after promulgation of NCTE Regulations 2014, the institution had consented to come under new Regulation by affidavit and the Revised Recognition order (RRO) was issued to the institution dated 29.04.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-2016.

3. AND WHEREAS, a verified complain was received from the Complaint Division of NCTE HQrs. vide letter No.NCTE- C/PG011/152/2023-Complaint Section-HQ/123799 dated 01.02.2024, thereafter the matter was considered by WRC in its 402nd Meeting held on 27th March, 2024, wherein the Committee decided as under: -
