SHOW CAUSE NOTICE

WHEREAS, in terms of Section 15 of the NCTE Act, 1993, Human Welfare Education Society, Kamla Nagar, City-Shimla, District-Shimla, Himachal Pradesh had submitted an application to the Northern Regional Committee of NCTE on 10.07.2006 for grant of permission to Sarvopalli Radha Krishnan Institution for Teacher Education, Racholi, Khaneri, Rampur, District-Shimla – 172001, Himachal Pradesh for B.Ed., B.Ed. (Add. Intake) and M.Ed. course of two years duration vide application No. HP184, HP-197 & HP-198

- 2. AND WHEREAS, the case of the institution alongwith was placed before the NRC in its 308th meeting held on 25th to 27th September, 2019 which on careful perusal of the Show Cause Notice, original file of the institution, NCTE Act, Rules, Regulations and guidelines issued by NCTE-Hqrs, decided to issue Show Cause Notice to the institution on the following grounds:-
  - 1. Certified registered land document not submitted. Only Jamabandi submitted.
  - 2. The institution has not submitted the Land Use Certificate issued by the Competent Authority to use the land for educational purpose.
  - 3. The institution has not submitted the Non-Encumbrance Certificate issued by the Competent Authority indicating that the land is free from all encumbrances.
  - 4. Built up area as per building plan is less for B.Ed. and M.Ed. courses.
  - 5. As regards D.D. of Rs 1.50 Lakhs, the institution has stated that they had already sent the D.D. of Rs. 40,000/- as per Regulations. As per NCTE Rules, 1997 amended vide Notification dated 13.09.2011, the fee of Rs. 40,000/- was enhanced to Rs 50,000/- effective from 01.04.2012.
  - 6. The institution has not submitted the Building Completion Certificate signed by the Competent Government Authority.
  - 7. Affidavit regarding land not submitted.

Hence, show cause notice under Section 14/15 (3)(b) of the NCTE Act, 1993 be issued to the institution to submit reply within 30 days from the date of issue of show cause notice.

- 3. NOW, THEREFORE, the institution is required to submit the representation/compliance accompanied with an affidavit from the authorized representative of the Management. The representation along with an affidavit must reach this office within the time specified at the end.
- 4. In case the reply submitted is incomplete or factually incorrect or not received in this office by the date mentioned at the end of this letter, then your application is liable to be rejected without any further opportunity.
- 5. It is expected that your reply shall reach this office through Courier / Registered AD/ Speed Post only. NCTE does not expect applicants to personally visit the RC Office for any reason whatsoever.
