REFUSAL ORDER

25 JUL 2019

WHEREAS, in terms of Section 15(1) of the NCTE Act, 1993, **Indresh Devi Charitable Trust, Plot No.-A-362, Street/Road-Sardhana Road, Village-Defence Enclave, Post Office-Kankarkhera, Tehsil-Meerut, District-Meerut - 250001, Uttar Pradesh** had submitted an application to the Northern Regional Committee of NCTE on 29.05.2015 for grant of permission to **Yug Institute of Management and Technology, Plot No. 236, 238, 242, 243, 244, Village -Ikri, Post Office-Ikri, Tehsil -Sardhana, Town-Meerut, District -Meerut - 250341, Uttar Pradesh** for **D.El.Ed. (Addl. Intake) Course of two years duration.**

AND, WHEREAS, the matter was considered by NRC in its 294<sup>th</sup> Meeting held on 28<sup>th</sup> to 29<sup>th</sup> January, 2019 and the Committee decided to issue Show Cause Notice u/s 15(3) (b) of the NCTE Act, 1993 giving 30 days time for submission of reply on the following grounds:-

- In the light of the order dt. 31.10.2018 in LPA. No. 619/2018 of the Hon'ble Delhi High Court and Letter No. 67/19/2018-US(Legal)Hq. dated 18.12.2018 and the ban imposed by the State Govt. vide letter No. 1188/68-4-2018 dt. 24.08.2018 to start D.El.Ed. course in the State of Uttar Pradesh, NRC, NCTE cannot process your application further.

AND, WHEREAS, Show Cause Notice was issued on 05.02.2019 to the institution.

AND, WHEREAS, the institution did not submit reply of Show Cause Notice.

AND, WHEREAS, the matter was considered by NRC in its 303<sup>rd</sup> meeting held from 10<sup>th</sup> to 12<sup>th</sup> July, 2019 and the Committee decided as under:-

- The institution has not submitted the reply of SCN issued on 05.02.2019.


Hence, the Committee decided that the application is rejected, and permission is refused u/s 15 (3)(b) of the NCTE Act, 1993. FDRs, if any, be returned to the institution.

NOW, THEREFORE, in exercise of the powers vested under Section 15 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuses permission to the institution on the grounds mentioned above.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE website [www.ncte-](http://www.ncte-)

india.org within 60 days from the date of issue of this order. The guidelines for filing of appeal may be seen on NCTE website.


