WITHDRAWAL ORDER

WHEREAS, recognition was granted by the Northern Regional Committee to **Amir Chand Kakkar College of Education, G.T. Road, Shahabad, Kurukshetra, Haryana** vide NRC order No. F. NRC/NCTE/F-3/HR-893/50276 dated 4th May, 2008 for B.Ed. course with an annual Intake 100 students followed by Revised Recognition order No. NRC/NCTE/HR-Common orders/2015/10870-72 dated 05th June, 2015 for annual intake of two units of 50 students each.

AND WHEREAS, the institution submitted representation on 16.11.2018 requesting to withdraw the recognition granted for B.Ed. course.


AND WHEREAS, the matter was placed before NRC in its 299th meeting held from 1st to 5th April, 2019 and the Committee, decided as under:

NRC decided to withdraw the recognition for B.Ed. course on request of the institution under Section 17 of the NCTE Act, 1993 from the end of the academic session next following the date of order of withdrawal.

NOW, THEREFORE, in exercise of the powers vested under section 17 of the NCTE Act, 1993, the Northern Regional Committee hereby withdraws recognition of **Amir Chand Kakkar College of Education, G.T. Road, Shahabad, Kurukshetra, Haryana** granted for B.Ed. course on the grounds mentioned above from the end of the academic session next following the date of order of withdrawal.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this Order. 
