Accordingly, a copy of the complaint was sent on 25.02.2019 to the institution.



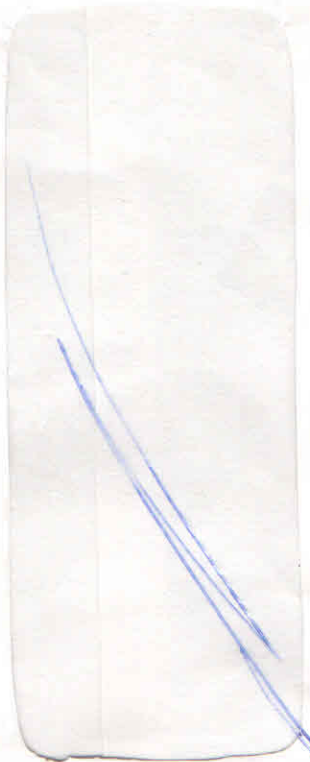
