## SHOW CAUSE NOTICE

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, Naveen Shiksha Samiti, Plot No.- Ward No.-2, Village- Mohindergarh, Post office- Mohindergarh, Tehsil-Mohindergarh, Twon - Mohindergarh, Dist.- Mahendragarh, Haryana-123029 had submitted an application to the Northern Regional Committee of NCTE on 16.12.2012 for grant of recognition/permission to Shri OP Memorial College of Education, Plot No.-815/1082, Street No.-Khudana, Village-Khudana, PO-Khudana, Tehsil-Mohindergarh, District-Mohindergarh, Haryana-123029 for D.El.Ed. course of two years duration.

AND WHEREAS, the matter was placed before NRC in its 299th meeting held from 1st to 5th April, 2019 and the Committee, decided as under:

The Committee decide to issue SCN on the following ground:

1. NOC from the affiliating body not submitted.

2. Director Elementary Education, Govt. of Haryana vide its letter Memo No. 5/6-2017 DIET(E-3) dated 01.03.2019 requested not to entertain any fresh opening/recognition or increase in intake of any D.El.Ed. course for the years 2019-20 and 2020-21. Hence, NRC, NCTE cannot process your application further.

Hence, show cause notice be issued under Section 14/15 (3)(b) of the NCTE Act, 1993 to the institution to submit reply within 30 days from the date of issue of show cause notice.

NOW, THEREFORE, the institution is required to submit the representation/compliance accompanied with an affidavit from the authorized representative of the Management. The representation along with an affidavit must reach this office within 30 days of the issue of this Notice. In case, the office does not receive any representation within stipulated time, it will be presumed that the institution does not wish to make any representation, and the Northern Regional Committee shall take decision as per provisions of the NCTE Act, Rules and Regulations.
