WHEREAS, in terms of Section 15 of the NCTE Act, 1993, Bahadurgarh Shiksha Sabha Regd, Plot No-2630-31, Street/Road- Bahadurgarh, Village/Town/City-Bahadurgarh, Post office- Bahadurgarh, Tehsil/Taluka- Bahadurgarh, District- Jhajjar, Haryana-124507 had submitted an application to the Northern Regional Committee of NCTE on 30.05.2015 for grant of permission to Vaish Arya Shikshan Mahila Mahavidayalaya, Plot No.-2630-31, Street No.-6, Village-Bahadurgarh, Post office-Bahadurgarh, Tehsil/Taluka-Bahadurgarh, Town/City-Bahadurgarh, District-Jhajjar, State-Haryana-124507 for B.Ed.M.Ed. 2. AND WHEREAS, the matter was placed before Northern Regional Committee in its 301st meeting held on 9th to 11th May, 2019 and the Committee, decided to issue Show Cause Notice under section 14 (3)(b) of the NCTE Act, 1993 giving specified time for submission of reply on the following grounds:-

In compliance with the order of the Hon'ble High Court of Delhi dated 08.01.2019, the case of the institution was considered by the NRC-NCTE and decided to issue SCN on the following grounds:

- 1. NOC of the affiliating body has not been submitted.
- 2. The institution has not submitted the certified copy of the registered land documents duly certified by the Registrar/ Sub-Registrar of the District.
- 3. The institution has not submitted the Notarized copy of Change of Land use Certificate issued by the Competent Govt. Authority.
- 4. The institution has not submitted Non-Encumbrance Certificate (NEC) signed by the Competent Govt. Authority.
- 5. The institution has not submitted the approved Building plan signed by the Competent Govt. Authority indicating the name of the course, address of the institution, Khasra No./Plot No., total land area, total built-up area and the measurements of the Multipurpose Hall as well as the other infrastructural facilities such as class rooms etc.
- 6. The institution has not submitted any proof / evidence to prove that it is a composite institution as per clause 2(b) of NCTE Regulations, 2014.
- 7. The institution has not submitted any proof/evidence of running B.Ed. and M.Ed. course for at least five years.
- 8. Proof of NAAC grading has not been submitted.
- 9. Proof of residential accommodation has not been submitted.

3. NOW, THEREFORE, the institution is required to submit the representation/compliance accompanied with an affidavit from the authorized representative of the Management. The representation along with an affidavit must reach this office within the time specified at the end.
