SHOW CAUSE NOTICE U/S 17

WHEREAS, recognition was granted by the Northern Regional Committee to **Ornate Institute of Technology**, Plot/Khasra No. – 64/1 and 64/2, Street No. – NA, Village/Town – Sampla Begumpur, Post Office – Sarsawa, Tehsil/Taluka – Nakur, Town City – Saharanpur, District – Saharanpur, Pin Code – NA, State – Uttar Pradesh vide Order No. NRC/NCTE/UP-3052/200<sup>th</sup> Meeting/2012/24314-321 dated 29.06.2012 for B.Ed. course of one year duration with an annual intake of 100 seats. In light of NCTE Regulations, 2014 revised recognition order No. NRC/NCTE/UP-3052/2015/11264-10 dated 06.06.2015 for B.Ed. course of two years duration with an annual intake of two units of 50 student each was issued to the institution with certain conditions.

AND WHEREAS, as per the decision of the Northern Regional Committee in its 281<sup>st</sup> Meeting, a Show Cause Notice u/s 17 was issued on 05.04.2018 to the institution on following grounds with a direction to submit the reply to Show Cause Notice within 21 days from the date of issue of SCN.

- The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds as per Regulations, 2014 and inform Regional Committees with required documents by May 30th, 2016.
- The application-Institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified Performa available on the website to the Regional Committee in proof of having provided additional facilities before May 30th, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
- The institution should have already identified/selected the faculty/staff by 29<sup>th</sup> February, 2016 for which the approval from the affiliating body for the same be submitted to this office immediately.
- The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition after May 30th, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.

- In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.

3. AND WHEREAS, the matter was considered by the Northern Regional Committee in its 308<sup>th</sup> Meeting held on 25<sup>th</sup> to 27<sup>th</sup> September, 2019 and the Committee, observed the following: -


a. The reply of SCN submitted by the institution vide letter dated 24.04.2018 is deficient on following grounds: -

- The FDRs has already been natured, renewal of the same is required. The institution not submitted FDRs as per Regulations, 2014.
- The institution has submitted building plan but the seal of the approving authority is not clear.
- The institution has not submitted the Building Completion Certificate signed by the Competent Government Authority.
- The institution has appointed only 12 teaching faculty in place of 16. The appointed faculty is also not qualified as per NCTE Regulations, 2014.

b. Accordingly, the Northern Regional Committee decided that a Final Show Cause Notice u/s 17 of the NCTE Act be issued to the institution to submit its representation / reply to the observations noted by the Regional Committee.


4. NOW, THEREFORE, the institution is required to submit the representation/compliance accompanied with an affidavit from the authorized representative of the Management. The representation along with an affidavit must reach this office within the time specified at the end.

5. In case the reply submitted is incomplete or factually incorrect or not received in this office by the date mentioned at the end of this letter, then proceedings under Section 17 (1) of the NCTE Act shall be brought to logical conclusion without any further opportunity provided in the matter whatsoever.
