SECOND SHOW CAUSE NOTICE U/S 17

WHEREAS, recognition was granted by the Northern Regional Committee to Pt. Akhand Pratap Narayan College of Education, Plot No. 243, Street/Road-Khalilabad, Vill-Ramsur, Post Office- Tama, Tehsil-Khalilabaddf, Dist-Sant Kabir Nagar, Pin Code-272175, State – Uttar Pradesh vide Order No. NRC/NCTE/NRCAPP-3290/225th Meeting/2013/721251-257 dated 05.03.2014 for B.Ed. course of one year duration with an annual intake of 100 seats. In light of NCTE Regulations, 2014 revised recognition order No. NRC/NCTE/NRCAPP-3290/2015/101326-331 dated 20.05.2015 for B.Ed. course of two years duration with an annual intake of two units of 50 student each was issued to the institution with following conditions.

- The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds as per Regulations, 2014 and inform Regional Committees with required documents by May 30th, 2016.
- The application-Institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified Performa available on the website to the Regional Committee in proof of having provided additional facilities before May 30th, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
- The institution should have already identified/selected the faculty/staff by 29th February, 2016 for which the approval from the affiliating body for the same be submitted to this office immediately.
- The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition after May 30th, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc

2. AND WHEREAS, the matter was considered by the Northern Regional Committee in its 308th Meeting held on 25th to 27th September, 2019 and the Committee, observed the following: -

- The institution has not submitted the Non-Encumbrance Certificate issued by the Competent Authority indicating that the land is free from all encumbrances.
- As per CLU, the diverted area is only for 2870 Sq. Mtrs., which is less for two units of B.Ed. course.
- The land area pertaining to Khasra No. 243 is only 2872 Sq. Mtrs. Which is less of required 3000 Sq. Mtrs. as per NCTE Regulations 2014.
- The Khasra No. is 215 mentioned in the building plan and BCC but land documents for the same is not submitted and this khasra number was also not mentioned in application form.
- The institution has submitted teacher faculty approved by Dr. Ram Dayal Gorakhpur University, Gorakhpur Uttar Pradesh on 10.02.2014 and 13.06.2016, the details of their qualifications is not given. Hence it is not clear whether they have qualification as per NCTE Regulation 2014 or not.

3. NOW, THEREFORE, the institution is required to submit the representation/compliance accompanied with an affidavit from the authorized representative of the Management. The representation along with an affidavit must reach this office within the time specified at the end.

4. In case the reply submitted is incomplete or factually incorrect or not received in this office by the date mentioned at the end of this letter, then proceedings under Section 17 (1) of the NCTE Act shall be brought to logical conclusion without any further opportunity provided in the matter whatsoever.

5. It is expected that your reply shall reach this office through Courier / Registered AD/ Speed Post only. NCTE does not expect applicants to personally visit the RC Office for any reason whatsoever.

6. Your reply, complete in all respects must reach this office on or before

14.11.2019
