FIRST SHOW CAUSE NOTICE U/S17

09 FEB 2024

WHEREAS, recognition was granted to the institution namely **GLOCAL COLLEGE OF EDUCATION, PLOT NO. 230/1, 231/2, VILLAGE-ROSHAMPUR PELO, POST OFFICE-MIRZAPUR, TEHSIL-BEHAT, DISTRICT-SAHARANPUR, UTTAR PRADESH-247001** for D.El.Ed. Course of two years duration with an annual intake of 50 students (1 unit) from the academic session 2016-17 vide NRC order NO. F. NO. NRC/NCTE/Recognition/D.El.Ed./2016/146821-7694 dated. 02.05.2016.

2. **AND WHEREAS**, matter was considered by NRC in its 417th meeting held on 04th January 2024 and committee decided as under: -

“The original file of the institution alongwith other related documents, NCTE Act, 1993, Rules, Regulations, SOP, and guidelines issued from time to time were placed before the Northern Regional Committee. The NRC made the following **decision**: -

The NRC observed that vide order dated 02.05.2016 “Global College of Education, Mirzapur, Behat, Saharanpur, Uttar Pradesh” was granted recognition for D.El.Ed. Course of 2 years duration with an annual intake of 50 (1 unit) under the affiliation of SCERT, Lucknow, U.P. It is clear that the Glocal University was never granted the recognition for D.El.Ed. Course and the Diploma issued by it for D.El.Ed. Course are not valid.

The NRC decided that the **First Show Cause Notice u/s 17 of NCTE Act, 1993 before withdrawal of recognition be issued** to the Glocal College of Education as to how and under which circumstances the Diploma for D.El.Ed. Courses were issued under the name of Glocal University instead of SCERT, Lucknow, Uttar Pradesh.”

3. The institution is required to submit the representation/compliance accompanies with an affidavit from the authorized representative of the Management. The representation along with an affidavit must reach this office within the time specified at the end.

4. In case the reply submitted is incomplete or factually incorrect or not received in this office by the date mentioned at the end of this letter, then it shall be treated as incomplete reply to the terms of this notice.

5. Yours reply, complete in all respects must reach this office within 30 days of issuance of this notice.
