FIRST SHOW CAUSE NOTICE U/S17

WHEREAS, recognition was granted to the institution namely V K Jain institute of Education, plot/khasara no-352,1/2, plot no. 352,1/2, street number – Sh33, Vill- Gorha, post office – Kasgunj, Teh/ Teluk-Kasgunj, Town/city-kasgunj,Dist-Etah (UP), State-UP, Pin-207123 for D.El.Ed. course of two years duration with an annual intake of 50 students from the academic session 2015-16 vide NRC order No. F.NRC/NCTE/NRCAPP-2859,NRCAPP-2914, NRCAPP-3719 NRCAPP-3734/235th Meeting/20125/ 99497-504 dated 23.04.2015.

2. AND WHEREAS, the institution has submitted a representation dated 17.07.2023 requesting to Surrender the recognition for the D.El.Ed. course.

3. AND WHEREAS, the matter was considered by NRC in its 406th Meeting (part-1) held on 01st to 3rd August, 2023 and the Committee decided as under: -

“The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were carefully considered by NRC and the Committee observed following:

The institution has submitted representation dated 17/07/2023 requesting to surrender the recognition for D.El.Ed. course.

The representation of the institution dated 17/07/2023 was considered by NRC and the committee decided to close/withdraw the recognition of D.El.Ed. course run by the institution. Therefore, the institution and all the concerned be informed accordingly.”

Accordingly, Withdrawal of Recognition was issued to the institution on 14.08.2023.

4. AND WHEREAS, the institution preferred an appeal. The appellate authority passed an Order No. File No 89-153/E-315360/2023/Appeal/11th Meeting 2023 APPLNRC202314665/122027dated. 10.10.2023 as under: -

Appeal Committee noted that the Hon’ble High Court of Delhi vide order dated 30.07.2021, passed in W.P. (c) 7260/2021 has observed as follows:-

“Although the appellate Committee of the NCTE would be well advised to expressly quash the original order of the concerned regional committee while remanding the matter, the position in law is that the order automatically stands quashed. The institution is, therefore , entitled to the benefits of recognition until a fresh withdrawal order is passed.”

- (iv) The institution is required to submit a Land Use Certificate issued by the Competent Government Authority to use the land for educational purposes.
- (v) The institution is required to submit a Non-Encumbrance Certificate issued by the Competent Government Authority indicating that the land is free from all encumbrances.
- (vi) The institution is required to submit a certified copy of a site plan with demarcated land area for running different courses.
- (vii) The institution is required to submit a Building safety certificate from the Competent Government Authority.
- (viii) The institution is required to submit a Fire safety certificate issued by the Competent Government Authority.
- (ix) The institution is required to submit a Certificate to the effect that the building is differently abled friendly from the Competent Government Authority.
- (x) The institution is required to submit a Building Completion Certificate signed by the Competent Government Authority.
- (xi) The institution is required to submit latest/current faculty list approved & signed each page by concerned affiliating body in original with the details of their teaching subject, date of birth, date of selection, date of joining, academic qualifications, teaching experience, NET/ Ph.D. (NCTE's GOI dated 09.06.2017), salary structure and related documents duly attested by authorized management representative not submitted. And, notarized original affidavit of Rs. 100/- on non-judicial stamp paper by the management and Rs. 10/- non-judicial stamp paper by each selected/ appointed faculty in the NCTE prescribed proforma.
- (xii) The institution is required to submit details of salary disbursed to the faculty along with six months Bank statement and account number of each faculty member.
- (xiii) The institution is required to submit original valid Fixed Deposit Receipts Nationalized/ Scheduled Bank towards Endowment & Reserve Fund in the joint operation mode with RD, NRC, NCTE & Management along with duly field Bank Form "A" in original, verified/ signed by the Manager of the Bank as per NCTE Regulations, 2014.
- (xiv) The institution is required to submit downloaded copies of documents from the website of the institution with hyperlinks of the same as per provisions of 7(14) of the NCTE Regulations, 2014.
- (xv) Status of NAAC.
- (xvi) The website of the institution is not updated as required under clause 8(6), 8(14) and 10(3) of NCTE Regulations, 2014.
- (xvii) The institution is required to submit a copy of the affiliation orders of last three academic years issued by the concerned affiliating body for each course being run by the institution / society.

6. The institution is required to submit the representation/compliance accompanies with an affidavit from the authorized representative of the Management. The representation along with an affidavit must reach this office within the time specified at the end.

In view of the afore –mentioned extract of the court order, the impugned withdrawal order dated 14.08.2023 is set aside as the appellate committee has decided to remand back the case to NRC for revisiting the matter.

IV DECISION: -

After perusal of the Appeal Report , documents on record and oral arguments advanced during the online hearing Appeal Committee of the council concluded to remand back the case to NRC with a direction to verify the submitted documents filed by the appellant institution with appeal from the records available with NRC and if it fail necessary and appropriate then documents may also be verified from the concerned competent authority . the appellant institution is directed to forward to the NRC the documents submitted in appeal within 15 days from the receipt of order of the appeal and after receipt of the same the NRC to take further necessary action as per the NCTE Regulation , 2014, guidelines and amendments issued from time to time in terms of direction given herein above.

5. **AND WEHREAS**, the institution representation received in NRC office on 21.08.2023, 01.09.2023 and 27.10.2023 was considered by the NRC in its 417th meeting held on 04.01.2023 and the committee decided as under: -

“The original file of the institution alongwith other related documents, NCTE Act, 1993, Rules, Regulations, SOP, order dated 19.12.2023 passed by the Appellate Authority of NCTE u/s 18 of NCTE Act and guidelines issued from time to time were placed before the Northern Regional Committee. The NRC made the following decision: -

“The Committee decided that a **First Show Cause Notice** before withdrawal of recognition of D.El.Ed course under Clause 17 of NCTE Act, 1993 be issued to the institution for submission of compliance with a period of 30 days from the date of issue of SCN on the following grounds: -

1. The institution is directed to submit the following: -
 - (i) The institution is required to submit proof / evidence to prove that it is a multi-disciplinary institution as per clause 2(b) of NCTE Regulations, 2014.
 - (ii) The institution is required to submit Certified registered land documents issued by the Registering Authority
 - (iii) The institution is required to submit Blueprint of approved Building plan signed by the Competent Govt. Authority indicating the name of the course, name of the institution, Khasra No./Plot No., total land area, total built-up area with the measurements of the Multi-purpose Hall as well other infrastructural facilities such as classrooms etc.

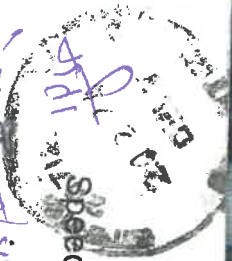
