FINAL SHOW CALLSE NOTICE LIGHT

The recognition was granted to the institution namely Beehive College of Advance Studies, Central Hope Town Selakui, Dehradun-248197, Uttranchal vide order No.NRC/NCTE/F-3/UR-28/4674 7683 dated 01.07.2005 for B.Ed. course of one-year duration with annual intake of 100 students. In light of NCTE Regulation, 2014 Revised Recognition Order No. NRC/NCTE/UR-28/2015/108425-33 dated 30.05.2015 for B.Ed. course of two-years duration was issued to the institution with an annual intake of 100 students was issued to the intuition with certain conditions.

2. AND WHEREAS, the institution has not submitted any document/ reply in compliance of the Revised Recognition Order. The matter was considered by the NRC in its 327th (Virtual) meeting held on February 08th & 10th 2021 and the Committee decided as under: -

"The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by NRC and the Committee made following observations:

The institution has not submitted Compliance of Regulations, 2014. Hence, NRC decided to direct institution to submit following documents:

- 1. The institution has not submitted any proof/evidence to prove that it is a composite institution as per clause 2(b) of NCTE Regulations, 2014.
- 2. Institution may inform steps taken by it to gradually become composite institution as per Clause 8(1) of Regulations, 2014.
- 3. Certified registered land documents issued by the Registering Authority or concerned authority has not been submitted.
- 4. Blue print of approved Building plan signed by the Competent Govt. Authority indicating the name of the course, name of the institution, Khasra No./Plot No., total land area, total built-up area with the measurements of the Multi-purpose Hall as well other infrastructural facilities such as class rooms etc. has not been submitted.
- 5. Land Use Certificate issued by the Competent Government Authority to use the land for educational purpose has not been submitted.
- 6. Non-Encumbrance Certificate issued by the Competent Government Authority indicating that the land is free from all encumbrances has not been submitted.
- 7. Certified copy of site plan with demarcated land area for running different courses has not been submitted.
- 8. Building safety certificate from the Competent Government Authority has not been submitted.
- 9. Fire safety certificate issued by the Competent Government Authority has not been submitted.
- 10. Certificate to the effect that the building is differently abled friendly from the Competent Government Authority has not been submitted.
- 11. Building Completion Certificate signed by the Competent Government Authority has not been submitted.
- 12. The latest/current faculty list approved & signed each page by concerned affiliating body in original with the details of their teaching subject, date of birth, date of selection, date of joining, academic qualifications, teaching experience, NET/Ph.D.(NCTE's GOI dated 09.06.2017), salary structure and related documents duly attested by authorized management representative not submitted. And, notarized original affidavit of Rs. 100/- on non-judicial stamp paper by the management and Rs. 10/- non-judicial stamp paper by each selected/appointed faculty in the NCTE prescribed proforma are required to be submitted.

13. Details of salary disbursed to the faculty along with six months Bank statement and account

number of each faculty member has not been submitted.

14. Copies of valid Fixed Deposit Receipts Nationalised/Scheduled Bank towards Endowment & Reserve Fund in the joint operation mode with RD, NRC, NCTE & Management alongwith duly field Bank Form "A" in original, verified/signed by the Manager of the Bank as per NCTE Regulations, 2014 are has not been submitted.

15. Downloaded copies of documents from the website of the institution with hyperlinks of the same as

per provisions of 7(14) of the NCTE Regulations, 2014 has not been submitted.

Hence, First Show Cause Notice under Section 17 of the NCTE Act, 1993 be issued to the institution to submit their reply accompanied with notarized affidavit of Rs. 100/- on Non-judicial stamp paper by the authorized representative of the Management within 30 days from the date of issue of show cause notice."

Accordingly, Show Cause Notice u/17 was issued to the institution on 27.02.2021.

3. AND WHEREAS, the matter was placed before the Northern Regional Committee in its 406th meeting held on 01st to 03rd August, 2023 in online mode. The Committee decided as under: -

"The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were carefully considered by NRC and the Committee observed following:

As per decision of NRC in its 327th meeting SCN under section 17 of NCTE Act, 1993 was issued to the institution on 27/02/2021.

The institution has not submitted reply of SCN dated 27/02/2021. The matter was considered in NRC and the Committee observed the following: -.

i. The institution is required to submit proof / evidence to prove that it is a Multi-disciplinary institution as per clause 2(b) of NCTE Regulations, 2014.

ii. The institution is required to submit Certified registered land documents issued by the Registering

Authority

iii. The institution is required to submit Blue print of approved Building plan signed by the Competent Govt. Authority indicating the name of the course, name of the institution, Khasra No./Plot No., total land area, total built-up area with the measurements of the Multi-purpose Hall as well other infrastructural facilities such as class rooms etc.

v. The institution is required to submit Land Use Certificate issued by the Competent Government

Authority to use the land for educational purpose.

- v. The institution is required to submit Non-Encumbrance Certificate issued by the Competent Government Authority indicating that the land is free from all encumbrances.
- vi. The institution is required to submit Certified copy of site plan with demarcated land area for running different courses.
- vii. The institution is required to submit Building safety certificate from the Competent Government Authority.
- iii. The institution is required to submit Fire safety certificate issued by the Competent Government Authority.
- ix. The institution is required to submit Certificate to the effect that the building is differently abled friendly from the Competent Government Authority.

x. The institution is required to submit Building Completion Certificate signed by the Competent

Government Authority.

xi. The institution is required to submit latest/current faculty list approved & signed each page by concerned affiliating body in original with the details of their teaching subject, date of birth, date of selection, date of joining, academic qualifications, teaching experience, NET/Ph.D. (NCTE's GOI dated 09.06.2017), salary structure and related documents duly attested by authorized management representative not submitted. And, notarized original affidavit of Rs. 100/- on non-judicial stamp paper by the management and Rs. 10/- non-judicial stamp paper by each selected/appointed faculty in the NCTE prescribed proforma.

- xii. The institution is required to submit details of salary disbursed to the faculty along with six months Bank statement and account number of each faculty members.
- xiii. The institution is required to submit copies of valid Fixed Deposit Receipts Nationalized/ Scheduled Bank towards Endowment & Reserve Fund in the joint operation mode with RD, NRC, NCTE & Management along with duly field Bank Form "A" in original, verified/ signed by the Manager of the Bank as per NCTE Regulations, 2014.
- xiv. The institution is required to submit downloaded copies of documents from the website of the institution with hyperlinks of the same as per provisions of 7(14) of the NCTE Regulations, 2014.
- xv. The institution has not adhere to the mandatory disclosure in the prescribed format and display up to date information on its official website as per NCTE Regulations 8(14) condition for grant of recognitions as per NCTE Regulations 2014.
- xvi. Status of NAAC.

Hence, the NRC decided that Final Show Cause Notice Under Section 17 of the NCTE Act, 1993 be issued to the institution to submit reply within 7 days from the date of issue of Show Cause Notice."

- 4. The institution is required to submit the representation/compliance accompanied with an affidavit from the authorized representative of the Management. The representation along with an affidavit must reach this office within the time specified at the end.
- 5. In case the submitted reply is incomplete or factually incorrect or not received in this office by the date mentioned at the end of this letter, then it shall be treated as incomplete reply to the terms of this notice.
- 6. Your reply, complete in all respects must reach this office within 07 days of issuance of this notice.
