### REFUSAL ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, JMK Educational Welfare Society, Plot No.- 0, Street/Road- NA, Village/Town/City- Majra Ramnagar, Post Office-Ramnagar, Tehsil/Taluka- Milak, Town/City- Milak, District- Rampur- 244901, Uttar Pradesh had submitted an application to the Northern Regional Committee of NCTE on 11.06.2015 for grant of recognition to JMK Institute of Technology and Management College, Plot No.- 02, 263, Street/Road- 0, Village/Town/City- Ramnagar, Post Office- Loha, Tehsil/Taluka- Milak, Town/City- Milak, District- Rampur- 244901, Uttar Pradesh for D.El.Ed. Course of two years duration.

AND, WHEREAS, the matter was considered by NRC in its 299th meeting held on 01st to 05th April, 2019 and the Committee decided to issue Show Cause Notice u/s 14(3) (b) of the NCTE Act, 1993 giving 30 days time for submission of reply on the following grounds:-

- 1. The institution has not submitted the approved Building plan signed by the Competent Govt. Authority indicating the name of the course, address of the institution, Khasra No./Plot No., total land area, total built-up area and the measurement of the Multipurpose Hall as well as the other infrastructural facilities such as class rooms etc.
- 2. Built-up area provided by the institution is less as per NCTE Regulation 2014.
- 3. VT has been constituted but the college owner denied the inspection on phone because the construction of college building has not been started vet.
- 4. As per letter No. 1188/68-4-2018 dt. 24.08.2018 received from Additional Chief Secretary, Govt. of UP, the State govt. requested NCTE not to grant recognition for D.El.Ed. course &DPSE course from session 2018-2019 for a period of 5 years. Hence, NRC, NCTE cannot process your application further.

AND, WHEREAS, Show Cause Notice was issued on 01.05.2019 to the institution.

AND, WHEREAS, the institution did not submit reply of Show Cause Notice dated 01.05.2019

AND, WHEREAS, the matter was considered by NRC in its 311th meeting held from 16th to 17th January, 2020 and the Committee decided as under:-

In the light of the order dt. 31.10.2018 in LPA. No. 619/2018 of the Hon'ble Delhi High Court and Letter No. 67/19/2018-US(Legal)Hq. dated 18.12.2018 and the ban imposed by the State Govt. vide letter No. 1188/68-4-2018 dt. 24.08.2018 to start D.El.Ed. course in the State of Uttar Pradesh, NRC, NCTE cannot process your application further.

The institution did not submit the reply to SCN dated 01.05.2019.

Hence, the Committee decided that the application is rejected and recognition/permission is refused u/s 14/15 (3)(b) of the NCTE Act, 1993. FDRs, if any, be returned to the institution.

Accordingly, by way of above proceeding the Northern Regional Committee in compliance of clause 14 (3) (b) of NCTE Act 1993 and NCTE Regulation, 2014 has given the due opportunity to the college and found it appropriate to reject the application.

NOW, THEREFORE, in exercise of the powers vested under Section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuses recognition to the institution on the aforesaid grounds.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE website <a href="www.ncte.gov.in">www.ncte.gov.in</a> within 60 days from the date of issue of this order. The guidelines for filing of appeal may be seen on NCTE website.
