REFUSAL ORDER 208 488

WHEREAS, in terms of Section 15(1) of the NCTE Act, 1993, Universal Society for Social Welfare, Plot No.- 23, Street/Road- Amiliha Road, Village/Town/City- Amiliha, Post Office- Tatiaganj, Tehsil/Taluka- Bilhaur, Town/City- Kanpur, District- Kanpur Nagar-209217, Uttar Pradesh had submitted an application to the Northern Regional Committee of NCTE on 30.06.2015 for grant of permission to Pt R K Shukla Degree College, Plot No.- 23, Street/Road-Amiliha Ro. Village/Town/City-Amiliha, Post Office-Tehsil/Taluka- Bilhaur, Town/City- Kanpur, District- Kanpur Nagar- 209217, Uttar Pradesh for D.El.Ed. Course of two years duration.

AND, WHEREAS, the matter was considered by NRC in its 313th (Part-2) meeting held from 25th to 27th February, 2020 and the Committee decided as under:-

1. In the light of the order dt. 31.10.2018 in LPA. No. 619/2018 of the Hon'ble Delhi High Court and Letter No. 67/19/2018-US(Legal)Hq. dated 18.12.2018 and the ban imposed by the State Govt. vide letter No. 1188/68-4-2018 dt. 24.08.2018 to start D.El.Ed. course in the State of Uttar Pradesh, NRC, NCTE cannot process your application further.

Hence, the Committee decided that the application is rejected and recognition/ permission is refused u/s 14/15 (3)(b) of the NCTE Act, 1993. FDRs, if any, be returned to the institution.

Accordingly, by way of above proceeding the Northern Regional Committee in compliance of clause 14 (3)(b) of NCTE Act 1993 and NCTE Regulation, 2014 has given the due opportunity to the college and found it appropriate to reject the application.

NOW, THEREFORE, in exercise of the powers vested under Section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuses recognition to the institution on the aforesaid
