FINAL SHOW CAUSE NOTICE U/S17

The recognition was granted to the institution namely **Army Institute of Education, Ring Road, Kandhar Kines Delhi Cantt, New Delhi-110010** for conducting **B.Ed. course** with annual intake of 100 students vide Order No.,NRC/NCTE/F-3/DH-178/2003/2369-2377 dated 05.07.2003.

2. After promulgation of NCTE Regulations, 2014, the institution has consented to come under the Regulations 2014 and an Affidavit in this regard was also submitted by the institution. Hence, Revised Recognition Order for **B.Ed. course** of two-year duration was issued to the institution with an annual intake of 100 students vide NRC/NCTE/DH-178/2015/90811-816 dated 11.03.2015

3. **AND WHEREAS**, the matter was placed before NRC in its 337th (Virtual) Meeting held on 26th March, 2021 and the Committee decided First Show Cause Notice Section 17 of the NCTE Act, 1993 be issued to the institution to submit reply within 30 days.

Accordingly, First Show Cause Notice was issued to the institution on 20.07.2021.

4. **AND WHEREAS**, the institution was submitted reply of Show Cause Notice date 20.07.2021 reply through email on 06.08.2021 and the matter was placed before NRC in its 366th (Vol.-1) Meeting held on 26th & 28th March, 2021 and the Committee decided that Final Show Cause Notice be issued under section 14/15(3(b) of the NCTE Act, 1993 to the institution to submit reply within 30 days from the date of issue of show cause notice. on the following grounds: -

1. Certified copy of registered land documents issued by the Registering Authority or concerned authority has not been submitted.
2. Affidavit relating to details of Land on Rs. 100/- Stamp paper not submitted.
3. Blueprint of the approved building plan signed by the Competent Govt. Authority indicating the name of the course, name of the institutions, Khasra No./Plot No., total land area, total built-up-area with the measurements of the Multipurpose Hall as well other infrastructural facilities such as class rooms etc. has not been submitted.
4. Land use Certificate issued by the Competent Government Authority to use the land for educational purpose has not been submitted.
5. Non -Encumbrance Certificate issued by the Competent Govt. Authority indicating that the land is free from all encumbrances has not been submitted.
6. Certified copy of Site plan with demarcated land area for running different courses has not been submitted.
7. Building Safety Certificate from the Competent-Government Authority has not been submitted.
8. Fire Safety Certificate issued by the competent govt. authority has not been submitted.
9. Certificate to the effect that the building is differently abled friendly from the competent Government Authority has not been submitted.
10. Building Completion Certificate signed by the Competent Government Authority has not been submitted.
11. The latest/ current faculty list approved & signed each page by the concerned affiliating body in original with the details of their teaching subject, date of birth, date of joining, academic qualifications, teaching experience, NET/Ph.D. (NCTE's GOI dated 09.06.2017), salary structure and related documents duly attested by the authorized management representative not submitted. Notarized original affidavit of Rs. 100/- on non-judicial stamp paper by the management and Rs. 10 - non-judicial stamp paper by each selected / appointed faculty in the NCTE prescribed proforma are required to be submitted.



12. Details of the salary disbursed to the faculty along with six months Bank statement and account number of each faculty member has been submitted by the institution but it is not clear.
13. Downloaded copies of documents from the website of the institution with hyperlinks of the same as per provisions of 7(14) of the NCTE Regulations, 2014 has not been submitted.
14. The institution is required to submit present status of affiliation.
15. The institution is required to submit the present status of composite institution.

Accordingly, Final Show Cause Notice was issued to the institution on 19.09.2022.

5. **AND WHEREAS,** the institution was not submitted reply of Final Show Cause Notice dated 19.09.2022. The matter was placed before NRC in its 411th (Blended Mode) Meeting held on 15th September, 2023 and the Committee decided as under:-

"The recognition was granted to the institution for B.Ed. course of one-year duration with an annual intake of 100 students vide order dated 05.07.2003. Further, revised recognition order for B.Ed. course of two years' duration with an annual intake of two basic units of 50 students each was issued to the institution vide dated 11.03. 2015. As per decision of NRC in its 337th meeting First SCN was issued to the institution on 20.07.2021. The institution has not submitted reply of first and second SCN. The matter considered in NRC and the committee observed the following:


- (I.) The institution is required to submit proof/ evidence to prove that it is a Multi-disciplinary institution as per clause 2(b) of NCTE Regulations, 2014
- (II.) The institution is required to submit Certified registered land documents issued by the Registering Authority
- (III.) The institution is required to submit Blue print of approved Building plan signed by the Competent Govt. Authority indicating the name of the course, name of the institution, Khasra No./Plot No., total land area, total built-up area with the measurements of the Multi-purpose Hall as well other infrastructural facilities such as class rooms etc.
- (IV.) The institution is required to submit Land Use Certificate issued by the Competent Government Authority to use the land for educational purpose.
- (V.) The institution is required to submit Non-Encumbrance Certificate issued by the Competent Government Authority indicating that the land is free from all encumbrances.
- (VI.) The institution is required to submit Certified copy of site plan with demarcated land area for running different courses.
- (VII.) The institution is required to submit Building safety certificate from the Competent Government Authority.
- (VIII.) The institution is required to submit Fire safety certificate issued by the Competent Government Authority.
- (IX.) The institution is required to submit Certificate to the effect that the building is differently abled friendly from the Competent Government Authority.
- (X.) The institution is required to submit Building Completion Certificate signed by the Competent Government Authority
- (XI.) The institution is required to submit latest current faculty list approved & signed each page by concerned affiliating body in original with the details of their teaching subject, date of birth, date of selection, date of joining, academic qualifications, teaching experience, NET/Ph.D. (NCTE's GOI dated 09.06.2017), salary structure and related documents duly attested by authorized management representative not submitted. And, notarized original affidavit of Rs. 100/- on non-judicial stamp paper by the management and Rs. 10/- non-judicial stamp paper by each selected/appointed faculty in the NCTE prescribed proforma.
- (XII.) The institution is required to submit details of salary disbursed to the faculty along with six months Bank statement and account number of each faculty members.
- (XIII.) The institution is required to submit copies of valid Fixed Deposit Receipts Nationalized/ Scheduled Bank towards Endowment & Reserve Fund in the joint operation mode with RD, NRC, NCTE & Management along with duly field Bank Form "A" in original, verified/signed by the Manager of the Bank as per NCTE Regulations, 2014.

- (XIV.) The institution is required to submit downloaded copies of documents from the website of the institution with hyperlinks of the same as per provisions of 7(14) of the NCTE Regulations, 2014.
- (XV.) The institution has not adhere to the mandatory disclosure in the prescribed format and display up to date information on its official website as per NCTE Regulations 8(14) condition for grant of recognitions as per NCTE Regulations 2014.
- (XVI.) Status of NAAC.

Hence, the NRC decided that Final Show Cause Notice Under Section 17 of the NCTE Act, 1993 be issued to the institution to submit reply within 7 days from the date of issue of Show Cause Notice."

6. The institution is required to submit the representation/compliance accompanied with an Affidavit from the authorized representative of the Management. The representation along with an Affidavit must reach this office within the time specified at the end.
7. In case, the submitted reply is in complete or factually incorrect or not received in this office by the date mentioned at the end of this letter, then it shall be treated as incomplete reply to the terms of this Notice.
8. Your reply, complete in all respects, must reach this office within **07 days** of issuance of this Notice.
