FIRST SHOW CAUSE NOTICE U/S 17

26 DEC 2019

WHEREAS, recognition was granted by the Northern Regional Committee to Jagwant Singh Bhaduria Public School, Plot/Khasara No.- 932, Street Number- 1, Village- Amaur, Post Office- Amaur, Tehsil/Taluka- Ghatampur, Town/City- Kanpur Sadar, District- Kanpur Nagar, Pin Code- 209401, State- Uttar Pradesh vide Order No. NRC/NCTE/NRCAPP-9489/233<sup>rd</sup> Meeting/89766-848 dated 03.03.2015 for B.Ed. course of two years duration with an annual intake of 2 units of 100 students from the academic session 2015-16.

2. AND WHEREAS, a complaint against the institution was received from Dr. Maya Singh Bhaduria, Manager, Jagwant Singh Bhaduria public School Samiti, Uttar Pradesh, on 14.06.2018 alleging the following: -

- "My Self Dr. Maya Singh bhaduria is a Manager of Jagwant Singh Bhaduria public School Samiti. This school is established on 2011 and running from 2012 April. It has on society, is made and registered on dated 31.05.2014. 2.5 Bigha land was purchased on 2012 by Shri Ram Gopal Singh Bhaduria and Shri Balwant Singh Bhaduria for this school and 6 Bigha land was leased from 30 years for Jagwant Singh Bhaduria Public School on dated 2014. NOC was also given for CBSE Board of this school. Affiliation from CBSE Board has been granted in 2016. Jagwant Singh Bhaduria Public School is running properly by 450 students.
- Mr. Brajesh Singh has taken Affiliation from NCTE Jaipur without my knowledge on this building and land. Application of B.Ed. was made without my knowledge whatever he submitted application and all documents which are invalid and totally fake in all aspects.
- Sir I humbly requesting you to cancel B.Ed. affiliation and immediately take action against it. Otherwise I would be forced to go high court for the future of my 450 students who are getting education from 2012 April."

3. AND WHEREAS, as per decision of the NRC in its 291<sup>st</sup> Meeting held on 15<sup>th</sup> to 16<sup>th</sup> November, 2018, Complaint forwarded for institution letter was issued on the institution on following grounds with a direction to submit the reply to this complaint on or before 28.11.2018.

4. AND WHEREAS, the institution did not submit any reply in NRC office till date. On consideration of the conditions mentioned in Section 17(1) of the NCTE Act, 1993 meriting withdrawal of recognition, the matter was placed before Northern Regional Committee in its 310<sup>th</sup> Meeting held on 20<sup>th</sup> to 22<sup>nd</sup> November, 2019 and the Committee decided to issue Show Cause Notice under Section 17 of the NCTE Act, 1993 giving specified time for submission of reply/documents on the following grounds: -

- The institution did not submit the reply regarding the complaint letter dated 28.11.2018.


