SECOND SHOW CAUSE NOTICE U/S 17 (FINAL OPPORTUNITY BEFORE WITHDRAWAL OF RECOGNITION)

WHEREAS, recognition was granted by the Northern Regional Committee to Shree Jagveer Singh Chauhan Smriti Mahavidyalaya, Village - Akbarpur, Lal Sahai, Post Office - Dhateengra, District - Etah, State - Uttar Pradesh vide Order No. NRC/NCTE/F-3/UP-1079/2004/7123 dated 28.08.2004 for B.Ed. course of one year duration with an annual intake of 100 seats from the academic session 2004-05. In light of NCTE Regulations, 2014 revised recognition order No. NRC/NCTE/UP-1079/2015/109182-87 dated 31.05.2015 for B.Ed. course of two years duration with an annual intake of two units of 50 student each was issued to the institution with certain conditions.

AND WHEREAS, Dr. B. R. A. University, Agra, stated in their letter No. 8040/2019 dated 19.01.2019 that एन०सी०टी०ई० द्वारा बी०एड० पाठ्यकम संचालन हेतु विनियमन 2014 लागू किया गया है उक्त विनियमन के प्रावधान के अनुसार आपके महाविद्यालय में बीoएडo पाठ्यक्रम में छात्रों के पठन पाठन हेतु एक यूनिट (50 छात्र) पर 0,803 (विशिष्ट विषय शिक्षक –फाईन आर्ट, संगीत एवं शारीरिक शिक्षा) 11 तथा दो यूनिट (100 छात्र) पर 16 शिक्षकों का अनुमोदन विश्वविद्यालय से प्राप्त करना चाहिये था, किन्तु विनियमन लागू होने क 04 वर्ष बाद भी आपके महाविद्यालय द्वारा न तो कोर-फैकल्टी और नही विशष्ट विषयों यथा 7 फाईन आर्ट, संगीत, शारीरिक शिक्षा हेतु शिक्षक अनुमोदित कराये गये है जो कि विनियमन 2014 के अनुसार नियम विरुद्ध है साथ ही माननीय कुलपित जी के दिनांक 16.11. 2017 के आदेशानुसार महाविद्यालय में पूर्व से कार्यरत शिक्षको का अनुमोदन 05 वर्ष पूर्ण होने पर शासनादेश संख्या 2218 / सत्तर-2-2011-16(409) / 2010 दिनांक 23.08.2011 के अनुपालन में विश्वद्यालय से पुनः अनुमोदन निरस्त कर दिया गया है। इस संबंध में सभी महाविद्यालयों की लॉगिन पर विश्वविद्यालय के पत्रांक संख्या संब / 4213 / 2017 दिनांक 17.11. 2017 के द्वारा सूचना अपलोड की गयी थी तथा विश्वविद्यालय द्वारा पुनः एक पत्र संख्या संब / 4361 / 2017 दिनांक 15.12. 2017 के द्वारा भी आपके महाविद्यालय में संचालित स्थायी बी०एड० पाट्यक्रम से संबंधित विभिन्न वॉछित सूचनायें उपलब्ध कराने हेतु महाविद्यालय की लॉगिन पर सूचना अपलोड करायी गयी थी। परन्तु आपके द्वारा उपरोक्त पत्रों के सापेक्ष में किसी तरह की सूचना आजतक उपलब्ध नहीं करायी गयी, जो कि संबद्धता शर्ती का उलंघन है। ऐसा प्रतीत होता है कि महाविद्यालय प्रबन्धन / प्रशासन उपरोकत पाठ्यक्रम को संचालित करने में रुचि नही ले रहा है।

AND WHEREAS, as per decision of the NRC in its 301st Meeting held on 09th to 11th May, 2019, a show cause notice u/s 17 was issued on the institution on following grounds with a direction to submit the reply to this show cause notice on or before 19.06.2019.

DAND WHEREAS, the institution has submitted reply in NRC office on 23.07.2019. The matter was considered by the Northern Regional Committee in its 310th Meeting held on 20th to 22 November, 2019 and the Committee, observed the following: -

The institution has not submitted approved faculty list in original with the details of their academic qualifications/ experience etc.

- The institution has not submitted the details of salary disbursed to the faculty along with six months Bank statement along with account number of each faculty members.
- The reply of SCN dated 19.06.2019 submitted by the institution is not satisfactory as it does not address the above deficiencies and the institution is being given final opportunity before withdrawal of recognition.
- Further, the website link showing the faculty details is not submitted by the institution.
- 5. AND WHEREAS, as the partial reply was received in response to the first SCN and it was observed by the committee that the following deficiencies are still there:
 - a) As informed by Dr. Bhim Rao Ambedkar University, Agra, Uttar Pradesh the institution failed to maintain the deserved number of staff/faculty during the period of recognition.
 - b) The reply submitted by the institution is incomplete because the documents submitted by the institution does not resolve the deficiencies indicated in first SCN u/s 17.
- c) The institution did not submit the bank statements deliberately, which is a violation of clause 10(2) of the NCTE (Recognition & Norms Procedure), Regulations, 2014. (thenceforth Regulations, 2014).
 - d) The institution is also violating the clause 7(14) of Regulations, 2014 by not maintaining the website details.
 - 6. Accordingly, the Northern Regional Committee decided that a Final/Second Show Cause Notice u/s 17 of the NCTE Act be issued to the institution <u>before withdrawal of recognition</u> to submit its representation / reply to the observations noted by the Regional Committee.
 - 7. NOW, THEREFORE, the institution is required to submit the representation/compliance accompanied with an affidavit from the authorized representative of the Management. The representation along with an affidavit must reach this office within the time specified in point 8 below.
 - 8. In case the reply submitted is incomplete or factually incorrect or not received in this office by the date mentioned at the end of this letter, then proceedings under Section 17 (1) of the NCTE Act shall be brought to logical conclusion without any further opportunity provided in the matter whatsoever.
 - 9. It is expected that your reply shall reach this office through Courier / Registered AD/ Speed Post only. NCTE does not expect applicants to personally visit the RC Office for any reason whatsoever.
