REFUSAL ORDER

WHEREAS, in terms of Section 14/(1) of the NCTE Act, 1993, Mata prasad Jaiswal Educational Society Itwa Siddharthnagar U P, Plot No. – 00, Street/Road – 00, Village/Town/City - Itwa, Post Office - Itwa, Tehsil/Taluka - Itwa, Town/City - Itwa, District - Siddharthnagar, State – Uttar Pradesh, Pin Code - 272192 had submitted an application to the Northern Regional Committee of NCTE on 01.01.2013 for grant of recognition/permission to Smt. Yasoda Devi Pandey Institute of Shikshan and Prashikshan Sansthan Itwa Siddharthnagar, Plot No. – 5/1228, Street/Road – 00, Village/Town/City - Itwa, Post Office - Itwa, Tehsil/Taluka - Itwa, Town/City - Itwa, District - Siddharthnagar, State – Uttar Pradesh, Pin Code - 272192 for D.El.Ed. course of two years duration.

AND, WHEREAS, the inspection of the institution was conducted by the Visiting Team constituted by NRC and the VTR was considered by NRC in its 2224<sup>th</sup> Meeting. As per decision taken by NRC, LOI under Clause 7(13) of NCTE Regulations, 2014 was issued to the institution on 27.06.2018. The matter was considered by NRC in its 301<sup>st</sup> Meeting held on 09<sup>th</sup> to 11<sup>th</sup> May, 2019 and as per decision SCN dated 23.05.2019 was issued to the institution on the following grounds: -

1. The institution did not submit any reply of the LOI issued on 27.06.2018 in NRC office till date.
2. In the light of the order dt. 31.10.2018 in LPA. No. 619/2018 of the Hon'ble Delhi High Court and Letter No. 67/19/2018-US(Legal)Hq. dated 18.12.2018 and the ban imposed by the State Govt. vide letter No. 1188/68-4-2018 dt. 24.08.2018 to start D.El.Ed. course in the State of Uttar Pradesh, NRC, NCTE cannot process your application further.

AND, WHEREAS, the institution did not submitted reply in NRC office. The matter was considered by NRC in its 311<sup>th</sup> Meeting held from 16<sup>th</sup> to 17<sup>th</sup> January, 2020 and the Committee decided that the application be rejected and permission/recognition be refused of the institution on the following grounds: -


1. The institution did not submit the reply of SCN dated 23.05.2019.
