Show Cause Notice U/S 17

WHEREAS, recognition was granted to the namely **Sree Narayana Gurudeva Training College, Palissery Poovathussery Post, Thrissur District- 680741, Kerala** for conducting B.Ed. course of one year duration with an intake of 100 students.

2. **AND WHEREAS**, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education notified the Regulations, 2014 on 01.12.2014.

3. **AND WHEREAS**, the institution has not consented to come under NCTE Regulations, 2014 and not submitted the required Affidavit to this effect.

4. **AND WHEREAS** the SRC in its 388st meeting held on 14th & 15th September 2020 considered the matter and decided to issue SCN in all such matters before withdrawal of recognition of the institution as per provision of the NCTE Act, 1993. Therefore, the institution is required to submit the following documents/information:-

1. The institution is required to explain the reasons for non-submission of affidavit giving consent of the institution to come under provisions of the NCTE Regulations, 2014.
2. The institution is required to submit latest affiliation status of the institution alongwith a copy of affiliation order of the affiliating body.
3. The Institution is required to clarify about running of institution at rented premises/private lease/govt lease or land on ownership basis. If the institution running on rented or private lease basis as on date the reason thereof for not shifting the premises to permanent building is required to be submitting by the institution. In case of shifting of premises from rented premises the institution is required to submit DD amounting to Rs.1,50,000/- (Rs. One lakh fifty thousand only) in favour of the Member Secretary, NCTE.
4. The institution should note that there should be no change of land and building documents except the addition of built up area in the approved building. Therefore the institution is required to submit land and documents submitted at the time of recognition and the present status of the same.
5. The institution is required to submit an undertaking that there is no charge in the name of Society/Trust(Management) which got the recognition of the institution and now submitting reply of SC

- (i) The institution is required to submit certified copy of land documents issued by concerned Tehsildar /Revenue Officer. (If the same are in Regional Language the institution is also required to submit notarised copy of English version of land documents)
- (ii) The institution is required to submit an attested/notarised copy of Land Use Certificate issued by the Competent Authority
- (iii) The institution has not submitted a copy of Non-Encumbrance Certificate issued by the Competent Authority. The institution is required to submit an attested/notarised copy of Non - Encumbrance Certificate issued by the Competent Authority.
- (iv) The institution is required to submit an attested/notarised copy of the approved Building Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an exclusive earmarked building plan for each of the recognised Teacher Education programme)
- (v) An attested/notarised copy of site plan showing all the plot/Survey No. mentioned in the land documents in one location alongwith land area and built up area.
- (vi) The Institution is required to submit an attested/notarised copy of Building Completion Certificate issued by the competent authority. The institution is required to submit Staff list duly approved by the Registrar of the
- (vii) affiliating body as per the prescribed Format. *(In case the institution is running more than one teacher education programme, it is required to submit staff list duly approved by the Affiliating body for each of the recognised teacher education programme being run by the Institution.)*
- (viii) The institution has not submitted original FDRs to the SRC, NCTE The institution is required to submit a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years alongwith a copy of the FDRs.

- (a) Details of land & building available at the time of recognition with the Institution
- (b) Details of land & building now available with the Institution
- (c) Status of Management at the time of recognition and its present status

In case of change of land & building or the Management at the time of recognition and thereafter the institution is required to specify the reason thereof with approval of the SRC, NCTE.

5. **Now, Therefore,** the institution is required to submit the representation/compliance accompanied with an affidavit from the authorized representative of the management. The representation along with an affidavit must reach this office within the time specified at the end

6. In case the reply submitted is incomplete or factually incorrect or not received in this office by the date mentioned at the end of this letter, then it shall be treated as incomplete reply to the terms of this notice.

7. It is expected that your reply shall reach this office through Courier/ Registered AD/ Speed Post only. NCTE does not expect applicants to personally visit the RC Office for any reason whatsoever.

8. Your reply, complete in all respect must reach this office on or before 30.9.2020.

In the event, this office does not receive any reply, it will be presumed that the institution has nothing to say and the Regional Committee shall take action for withdrawal of recognition.
