WHEREAS, the recognition was granted to Mahatma College of Education, Sangeetha Building, Raja Road, Nileshwar, Kasargod District-671314, Kerala for B.Ed Course of One-year duration with an annual Intake of 100 Students vide NCTE's Order No. F. SRO/NCTE/2007-2008/18816 dt 17.03.2008.

AND WHEREAS, as per the records, the recognition was granted to the institution on the rented/temporary premise with the condition to shift the premise to owned by trust/Institution within a period of 3 years from the date of recognition.

- 1. The institution is required to explain the reasons for non compliance of condition for shifting of institution from rented to permanent premises.
- 2. The institution is required to submit a certified copy of land documents. The institution is required to submit certified copy of land documents issued by concerned Tehsildar /Revenue Officer. (If the same are in Regional Language the institution is also required to submit notarised copy of English version of land documents)
- 3. The institution is required to submit a copy of Land Use Certificate. The institution is required to submit an attested/notarised copy of Land Use Certificate issued by the Competent Authority.
- 4. The institution is required to submit a copy of Non Encumbrance Certificate issued by the Competent Authority. The institution is required to submit an attested/notarised copy of Non Encumbrance Certificate issued by the Competent Authority.
