FINAL SHOW CAUSE NOTICE U/S 17

WHEREAS, the recognition was granted to the institution namely **Dr. Rajabather Tagore Women Teacher Training College, No. 88-E, Gingee Road, Tindivanam-604001, Tamilnadu** was granted recognition vide SRC (NCTE) order no. F.TN/SRO/NCTE/2005-06/4968 dated 26.12.2005 for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the academic session 2005-2006 with the condition to the institution shall shift to its own premises/building with three years from the date of recognition. (in case the course is started in rented premises).

2. **AND WHEREAS**, SRC in its 181st meeting held on 20th – 21st August 2009 considered the files of the institution who have been granted recognition in rented premises and decided to issue notice under section 17 of NCTE Act.

3. **AND WHEREAS**, as per the decision of SRC, a notice was issued to the institution on 16.09.2009 seeking explanation and relevant documents with respect to shifting of premises.

4. **AND WHEREAS**, the institution submitted a reply on 29.09.2009 stating that they have shifted to own building at kilgudalore Village, Krishnaveni Nagar, Tindivanam Taluk in Sy. No. 12/1. The institution submitted a shifting fee of Rs. 40,000/- vide its letter dated 30.09.2009.

5. **AND WHEREAS**, Further, no action is seen in the file.

6. **AND WHEREAS**, the institution has submitted willingness affidavit as per regulations 2014 on 02.03.2015. Accordingly, revised recognition order was issued to the institution on 12.05.2015. with the condition to that the institution has not shifted to its own premises as stipulated in its formal recognition order dated 06.01.2006.

7. **AND WHEREAS**, the institution has submitted a letter dated 02.11.2015 along with staff list.

8. **AND WHEREAS**, the Southern Regional Committee in its 318th Meeting held during 8th and 9th August, 2016 considered the matter, documents submitted by the institution.

9. **AND WHEREAS**, on 07.09.2016, the institution has submitted a representation.

10. **AND WHEREAS**, the Southern Regional Committee in its 340th Meeting held during 8th -9th June 2017 considered the matter, documents submitted by the institution.

11. **AND WHEREAS**, a Show Cause Notice was issued to the institution on 16.06.2017. The institution has submitted its reply on dt. 14.07.2017 in respect of SCN issued.

12. **AND WHEREAS**, the matter was further considered by the SRC meeting 386th held on 23rd – 24th July, 2020 and the Committee decided as under:

“The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee considered the Show Cause Notice’s reply submitted by the institution on 14.07.2017 and found the following deficiencies: -

1. **The institution did not rectify the deficiencies communicated vide Show Cause Notice dated 16.06.2017.**
2. **As per NEC the land is agricultural.**

Therefore, the Committee decided to issue **Final Show Cause Notice u/s 17 of NCTE Act, 1993** before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 21 days from the date of issue of **Final Show Cause Notice.**”

13. **NOW, THEREFORE**, the institution is required to submit the representation/compliance accompanied with an affidavit from the authorized representation of the Management. The representation along with an affidavit must reach this office within the time specified at the end.

15. It is expected that your reply shall reach this office through Courier/Registered AD/Speed Post only. NCTE does not expect applicants to personally visit the RC Office for any reason whatsoever.
16. Your reply, complete in all respects must reach this office **within 21 days** of the issue of this **Final Show Cause Notice**.
