Final Show Cause Notice U/S 17 Act 1993

Whereas, the institution namely J. K College of Education, Narpavalakkudi, Kannakurumbi, Arantangi, Pudukkottai District, Tamilnadu-614616 was granted recognition for conducting (B.Ed.) course of one-year duration with an annual intake of 100 students vide SRC, NCTE's vide order no. F.No.SRO/NCTE/B.Ed./2007-2008/2045 dt. 05.06.2008.

And Whereas, after the promulgation of NCTE Regulations, 2014 and as per affidavit submitted by the institution on dt. 29.01.2015, and the provisional revised recognition order was issued on dt. 30.04.2015 to the institution for conducting <u>B.Ed. programme of two years duration with an annual intake of 100 students each for two basic units</u> from the academic session 2015-2016.

And Whereas, the matter was placed before the SRC in its 380th meeting held on 18th -19th September, 2019 wherein the Committee considered the matter and decided a Final Show Cause Notice was issued to the institution. As per the decision a Final Show Cause Notice was issued to the institution on 04.10.2019. The institution submitted its reply along with documents on dt. 23.10.2019.

And Whereas, the SRC in its 386th meeting held on 23rd & 24th July 2020 and considered the matter and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee considered the Show Cause Notice's reply submitted by the institution on 23.10.2019 and found the following deficiencies: -

- 1. The Lease Deed dt. 23.10.2019 executed between private parties are not acceptable/allowed under NCTE Regulations, 2014.
- 2. Other documents like Building Plan, NEC, CLU and BCC are not acceptable under NCTE Regulations.
- ${\bf 3.} \ \ {\bf The~size~of~Multipurpose~Hall~is~less~than~the~requirement~of~NCTE~Regulations, 2014.}$
- 4. The FDR of Rs.4 lakhs submitted by the institute is from Lakshmi Vilas Bank which is not acceptable as per NCTE Regulations.
- 5. The institute failing in submission of faculty list duly approved by the Competent Authority."

In case the reply submitted is incomplete of factually incorrect of not received in this office by the date mentioned at the end of this letter, then proceedings under Section 17(1) of the NCTE Act shall be brought to logical conclusion without any further opportunity provided in the matter whatsoever.
- 8. It is expected that your reply shall reach this office through Courier/Registered AD/Speed Post only. NCTE does not expect applicants to personally visit the RC Office for any reason whatsoever.
- 9. Your reply, complete in all respects must reach this office within 21 days of the issue of this Final Show Cause Notice.
