**FINAL SHOW CAUSE NOTICE U/S 17**

WHEREAS, recognition was granted by the Southern Regional Committee to the institutions for B.Ed./M.Ed. & B.P.Ed Course (as per list enclosed)

2. **AND WHEREAS**, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education notified the Regulations, 2014 on 01.12.2014.

3. **AND WHEREAS**, the institutions submitted a notarized affidavit consented to come under new Regulations which required additional facilities subject to the institution fulfilling following conditions, namely:-

I. The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by *October 31<sup>st</sup>, 2015*.

II. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified performa available on the website to the Regional Committee in proof of having provided additional facilities before *October 31<sup>st</sup>, 2015*. Building Completion Certificate (BCC) may be given along with other documents if available; otherwise it can also be given to the Visiting team at the time of inspection.

III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by *October 31<sup>st</sup>, 2015*. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.

4. **AND WHEREAS**, the grounds / lapses of disaffiliation of TEIs communicated vide e-mail dt. 11.02.2020 are placed on the table of the Committee alongwith the original files. The

institution along with regulatory file was placed before the SRC in its 384<sup>th</sup> meeting held on 12<sup>th</sup> - 13<sup>th</sup> February 2020 and the Committee decided as under:

*“The email received from the Registrar, Tamil Nadu Teacher Education University, Chennai dt 11.02.2020, the Committee resolved to serve Final Show Cause Notice to all the institutions informing the reasons foot forth by the university for each college.”*

Further, the office is also advised to exclude the colleges whose recognition is already withdrawn, for such institutions no need to send Final Show Cause Notice.

**Final Show Cause Notice to the institution for B.Ed/M.Ed. course to submit the following documents / representation:-**

1. The institution is required to submit certified copy of land documents issued by concerned Tehsildar /Revenue Officer. (If the same are in Regional Language the institution is also required to submit notarised copy of English version of land documents)
2. The institution is required to submit an attested/notarised copy of Land Use Certificate issued by the Competent Authority.
3. The institution is required to submit an attested/notarised copy of Non - Encumbrance Certificate issued by the Competent Authority.
4. The institution is required to submit an attested/notarised copy of the approved Building Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an exclusive earmarked building plan for each of the recognised Teacher Education programme)
5. An attested/notarised copy of site plan showing all the plot/Survey No. mentioned in the land documents in one location alongwith land area and built up area.
6. The Institution is required to submit an attested/notarised copy of Building Completion Certificate issued by the competent authority.
7. The institution is required to submit Staff list duly approved by the Registrar of the affiliating body as per the prescribed Format. *(In case the institution is running more than one teacher education programme, it is required to submit staff list duly approved by the Affiliating body for each of the recognised teacher education programme being run by the Institution.)*
8. The institution is required to submit a “Form A” issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totaling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years alongwith a copy of the FDRs
