## **ORDER**

WHEREAS, the recognition was granted to the institution namely Rayalaseema College of Education, 19-8-150, Rayalaseema Nagar, Bairagipatteda, Tirupati, Chittoor District, Andhra Pradesh run by Siddartha Educational Academy, Tirupati, Andhra Pradesh vide SRC (NCTE) order no. F.No.SRO/NCTE/ASP08713/B.Ed/2007-2008/10249 dt. 30.08.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 19.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic unit) from the academic session 2015-16.
- 3. AND WHEREAS, the matter was placed before the southern regional committee in its 368<sup>th</sup> meeting held from 08<sup>th</sup> to 09<sup>th</sup> January, 2019. The committee decided to SCN. Accordingly, as per the decision of SRC, a Show Cause Notice was send to the intuition on 18.01.2019. The institution submitted reply to the show cause notice on 05.02.2019. The matter was placed before the southern regional committee in its 374<sup>th</sup> meeting held from 09<sup>th</sup> 10<sup>th</sup> April, 2019. The committee decided to issue SCN. Accordingly, as per the decision of SRC, a Show Cause Notice was send to the intuition on 22.04.2019.
- 4. AND WHEREAS, the SRC in its 381st meeting held on 31st Oct 01st Nov 2019 considered the after and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, a Final Show Cause Notice was issued on 20.11.2019. The institutions vide letter dated 27.12.2019 & 12.03.2020 submitted reply to the alongwith land & building documents having address as Survey No. 239 of Tirupati, 8<sup>th</sup> Street, 19<sup>th</sup> Ward, H.No. 150, (19-8-150), Municipal Corporation, Tirupati-517507, Chittoor District, Andhra Pradesh and staff list etc.
- 5. AND WHEREAS, the SRC in its  $388^{th}$  meeting held on  $14^{th}-15^{th}$  September, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution vide letter dt. 13.03.2020, the Committee decided that the continuation order be issued to the Institution Rayalaseema College of Education, Chittoor District, Andhra Pradesh for B.Ed. programme for 2 basic unit (50 students each unit).

- 6. NOW THEREFORE, this order is issued permitting the institution i.e. Rayalaseema College of Education, Survey No. 239 of Tirupati, 8<sup>th</sup> Street, 19<sup>th</sup> Ward, H.No. 150, (19-8-150), Municipal Corporation, Tirupati-517507, Chittoor District, Andhra Pradesh run by Siddartha Educational Academy, Tirupati-517507, Andhra Pradesh for continuation of recognition for B.Ed course of two years duration with an intake of 100 students (2 basic units) of subject to fulfillment of the following conditions:-
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.

- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 7. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable
- 8. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 9. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.

- The institution shall be free to post additional relevant information, if it so desires. j.

- The institution shall adhere to the mandatory disclosure in the prescribed format and 10. display up-to-date information on its official website.
- The institution shall make available the list of students admitted on its official website. 11.
- The institution shall fill the information on GIS Portal on the NCTE Website. 12

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
