SHOW CAUSE NOTICE U/S 17

WHEREAS, the recognition was granted to the institution namely **Sri Srinivasa D.Ed College, Plot No. Patta No 279, Balayapalli (V&P), Venkatagiri (T), Nellore District-524404, Andhra Pradesh** run by **Sri Madhavi Educational Society, Plot No. 1-415 Main Road, Malavya Nagar Village, Guntur Post & Taluka, Nellore District- 524401, Andhra Pradesh** vide SRC (NCTE) order no. **F.SRO/NCTE/SRCAPP14954/D.El.Ed/AP/2016-2017/84618 dt 27.04.2016** for conducting D.Ed. course of two-year duration with an annual intake of **50 students (1 Unit)** from the academic session 2016-17.

2. **AND WHEREAS**, a letter No. RC.No. 359/A/SCERT/2019 dated 29.6.2020 is received from the Commissioner, School Education (FAC), School Education Department, Govt. of Andhra Pradesh on 17.07.2020 recommending therein for derecognition order in respect of 188 Pvt. D.El.Ed. Colleges in A.P. since the said managements of Pvt. D.El.Ed. Colleges have made admission into the D.El.Ed. Course during academic year 2018-19 on their own in violation of Government orders.

3. **AND WHEREAS**, the matter was considered by SRC in its 386th meeting held on 23rd-24th July, 2020 and decided as under:

The Committee decided to issue Show Cause Notice asking them to submit following documents/information:-

1. The institution is required to explain about the observations made by the School Education Department, Govt. of Andhra Pradesh vide letter No. RC.No. 359/A/SCERT/2019 dated 29.6.2020
2. The institution is required to submit certified copy of land documents issued by concerned Tehsildar /Revenue Officer. (If the same are in Regional Language the institution is also required to submit notarised copy of English version of land documents)
3. The institution is required to submit an attested/notarised copy of Land Use Certificate issued by the Competent Authority.
4. The institution has not submitted a copy of Non-Encumbrance Certificate issued by the Competent Authority. The institution is required to submit an attested/notarised copy of Non - Encumbrance Certificate issued by the Competent Authority.
5. The institution is required to submit an attested/notarised copy of the approved Building Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an exclusive earmarked building plan for each of the recognised Teacher Education programme)
6. An attested/notarised copy of site plan showing all the plot/Survey No. mentioned in the land documents in one location alongwith land area and built up area.
7. The Institution is required to submit an attested/notarised copy of Building Completion Certificate issued by the competent authority.
8. The institution is required to submit Staff list duly approved by the Registrar of the affiliating body as per the prescribed Format. (In case the institution is running more than one teacher education programme, it is required to submit staff list duly approved by the Affiliating body for each of the recognised teacher education programme being run by the Institution.)
9. The institution has not submitted original FDRs to the SRC, NCTE The institution is required to submit a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh

and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years alongwith a copy of the FDRs

14. The institution shall be required to submit an Affidavit clearly stating status about land & building and Management (Society/Trust) at the time of recognition and its present status giving following details

- (i) Details of land & building available at the time of recognition with the Institution
- (ii) Details of land & building now available with the Institution
- (iii) Status of Management at the time of recognition and its present status

In case of change of land & building or the Management at the time of recognition and thereafter the institution is required to specify the reason thereof with approval of the SRC, NCTE.

4. **NOW THEREFORE**, the institution is required to submit the representation/compliance accompanied with an affidavit from the authorized representation of the Management. The representation along with an affidavit must reach this office within the time specified at the end.

5. In case the reply submitted is incomplete or factually incorrect or not received in this office by the date mentioned at the end of this letter, then it shall be treated as incomplete reply to the terms of this notice.

6. It is expected that your reply shall reach this office through Courier/Registered AD/ Speed Post only, NCTE does not expect applicants to personally visit the RC office for any reason whatsoever.

7. Your reply, complete in all respects must reach this office within 21 days of issuance of this notice.
