Withdrawal Order

Whereas, the institution Soundaraa Teacher Training Institute, 2/6, Thotakal Road, Karaamanikuppam, Pondicherry-605004 was granted recognition vide SRC (NCTE) order no. F.PN/ELE/SRO/NCTE/2005-2006/5809 dt. 18.04.2006 for conducting D.T.Ed. course of one year duration with an annual intake of 100 students from the academic session 2005-2006 with a condition to shift the institution to permanent premises. The institution in its application stated that the institution possess own land for construction of permanent building.

And Whereas, the matter was placed before the SRC in its 181st meeting held on 20th & 21st August, 2009 considered the matter and decided to issued Show Cause Notice to such institution which are running on Rented Premises and have not shifted to own permanent building even after stipulated time period of 3 years.

And Whereas, a SCN was issued to the institution vide dt. 14.09.2009. The institution did not submit any reply till date.

And Whereas, the SRC in its 387th meeting held on 24th & 25th August 2020 and considered the matter as under:-

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee noticed that the institutions which were granted recognition on Rented Premises with a condition to shift its building to new permanent building. And the institutions which have not yet shifted to its own permanent building.

- The institution has not shifted its institution to own permanent building, which is a violation of the NCTE Regulations 2002, 3(c).
- The institution has also not responded to the Show Cause Notice issued on 14.09.2009."

And Whereas, the Committee decided to Withdraw the recognition granted to Soundaraa Teacher Training Institute, 2/6, Thotakal Road, Karaamanikuppam, Pondicherry - 605004 for conducting B.Ed. course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

-:2:-

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website www.ncte-india.org, with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
