SHOW CAUSE NOTICE U/S 17

WHEREAS, the recognition was granted to the institution namely Sai Deepthi College of Elementary Education, Plot No. 23, NH5, Edulapalem Village, Yanamadala P.O., Prathipadu Taluk, Guntur Rural City, Guntur District – 522019, Andhra Pradesh run by Faith Educational Society, D.No. 8-154, RK Street, Chilakaluripet Village & Post, Chilakaluripet Taluk & City, Guntur District – 522616, Andhra Pradesh vide SRC (NCTE) order no. F.No.SRO/NCTE/SRCAPP15068/D.El.Ed/AP/2016-2017/83852 dt 12.04.2016 for conducting D.El.Ed. course of two-year duration with an annual intake of 100 students (2 units) from the academic session 2016-2017.

- 2. AND WHEREAS, a letter No. RC.No. 359/A/SCERT/2019 dated 29.6.2020 is received from the Commissioner, School Education (FAC), School Education Department, Govt. of Andhra Pradesh on 17.07.2020 recommending therein for derecognition order in respect of 188 Pvt. D.El.Ed. Colleges in A.P. since the said managements of Pvt. D.El.Ed. Colleges have made admission into the D.El.Ed. Course during academic year 2018-19 on their own in violation of Government orders.
- **3. AND WHEREAS,** the matter was considered by SRC in its 386th meeting held on 23rd-24th July, 2020 and decided as under:

The Committee decided to issue Show Cause Notice asking them to submit following documents/information:-

- 1. The institution is required to explain about the observations made by the School Education Department, Govt. of Andhra Pradesh vide letter No. RC.No. 359/A/SCERT/2019 dated 29.6.2020
- 2. The institution is required to submit certified copy of land documents issued by concerned Tehsildar /Revenue Officer. (If the same are in Regional Language the institution is also required to submit notarised copy of English version of land documents)
- 3. The institution is required to submit an attested/notarised copy of Land Use Certificate issued by the Competent Authority.
- 4. The institution has not submitted a copy of Non-Encumbrance Certificate issued by the Competent Authority. The institution is required to submit an attested/notarised copy of Non-Encumbrance Certificate issued by the Competent Authority.
- 5. The institution is required to submit an attested/notarised copy of the approved Building Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an exclusive earmarked building plan for each of the recognised Teacher Education programme)
- 6. An attested/notarised copy of site plan showing all the plot/Survey No. mentioned in the land documents in one location alongwith land area and built up area.
- 7. The Institution is required to submit an attested/notarised copy of Building Completion Certificate issued by the competent authority.
- 8. The institution is required to submit Staff list duly approved by the Registrar of the affiliating body as per the prescribed Format. (In case the institution is running more than one teacher education programme, it is required to submit staff list duly approved by the Affiliating body for each of the recognised teacher education programme being run by the Institution.)
