WHEREAS, the recognition was granted to the institution namely B S N Memorial College of Elementary Teacher Education, Plot/Khasara No. 172, Plot. 18/5A & 18/6A, Kummaravee Street, Kothavalasa Village & Post, Kothavalasa Taluk & City, Vizianagaram District-535183, Andhra Pradesh run by Pedro Educational Welfare Society, Plot No. 302, Latha Hospital Road, Waltair Up Lands Village, Andhra University Post, Visakhapatnam Urban Taluk Visakhaptnam City, Vizianagaram District-530003, Andhra Pradesh for conducting D.El.Ed & D.El.Ed-Al course of two-year duration with an annual intake of 50 students.

- (i) The SRC vide Order No. F.SRC/NCTE/APSO2544/D.Ed/2005-2006/2599 dt. 26.08.2005 for conducting D.Ed course of two-year duration with an annual intake of 50 students.
- (ii) The SRC vide order No. SRO/NCTE/SRCAPP14129/D.EI.Ed-Al/AP/2016-2017/83988 dt.12.04.2016 for conducting D.EI.Ed-Al. course of two-year duration with an annual intake of 50 students

AND WHEREAS, the SRC in its 384^{th} meeting held on $12^{th}-13^{th}$ February, 2020 considered the matter of the institution regarding **B.Ed.** programme being run by the institution and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Management of the Institution had not submitted required documents in response to letter issued to the Institution on 05.10.2018. Another opportunity was given to the institution by serving a Final Show Cause Notice (FSCN) dated 08.11.2019. The institution vide letter dated 02.12.2019 submitted its reply/representation in response to Final Show Cause Notice (FSCN). On perusal of the same the Committee found that the institution has not submitted requisite documents mentioned in Show Cause Notice & Final Show Cause Notices and observed the following deficiencies:-

- (i) The institution has not appointed faculty as per NCTE Regulations, 2014.
- (ii) Building plan submitted by the institution is not approved by the competent authority.
- (iii) The institution has not submitted certified copy of the land documents.

Hence, the Committee decided to withdraw the recognition granted to B.S.N. Memorial College of Education, 1033, Kumaraveedi, Kothavalsa, Vizianagaram District – 535 183, Andhra Pradesh for conducting B.Ed course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Therefore, the Committee decided to issue Final Show Cause Notice u/s 17 of NCTE Act, 1993 before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 21 days from the date of issue of Final Show Cause Notice.

AND WHEREAS, in compliance of the decision of the SRC, a withdrawal order for B.Ed. programme has been issued vide order No. F.SRO/NCTE/APSO0316/B.Ed/AP/2020/115286-115292 dated 26.02.2020. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 11.03.2020. The institution vide letter dated 14.05.2020 its reply to the Final Show Cause Notice

AND WHEREAS, the SRC in its 389^{th} meeting held during $12^{th} - 14^{th}$ October, 2020 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN) dated 05.08.2020. The institution has submitted its reply on 14.05.2020. The Committee considered the reply and found the following deficiencies: -

 The institution has submitted photocopy of building plan which is not in favour of institution / society. And, the size of multipurpose hall is not mentioned.

2. The institution has not submitted the site plan duly approved by the competent authority.

3. The institution has submitted photocopy of faculty appointed in D.El.Ed course but the same is not under prescribed format.

Hence, the Committee decided to withdraw the recognition granted to B S N Memorial College of Elementary Teacher Education, Plot/Khasara No. 172, Plot. 18/5A & 18/6A, Kummaravee Street, Kothavalasa Village & Post, Kothavalasa Taluk & City, Vizianagaram District- 535183, Andhra Pradesh for conducting D.Ed. & D.El.Ed-Al courses w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of B S N Memorial College of Elementary Teacher Education, Plot/Khasara No. 172, Plot. 18/5A & 18/6A, Kummaravee Street, Kothavalasa Village & Post, Kothavalasa Taluk & City, Vizianagaram District-535183, Andhra Pradesh for conducting D.Ed & D.El.Ed-Al programme of two years duration

with an annual intake of 100 students (2 units) from the next academic session starts after issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
