FINAL SHOW CAUSE NOTICE U/S17

WHEREAS, the recognition was granted to the institution namely S.A.R. College of Education, No.2-151, Visakanagar Colony, Jammu Village, Vizianagaram District-535005, Andhra Pradesh run by S.A.R. Educational Society, Vizianagaram District, Pin-535270, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/2006-2007/4857 dt. 20.06.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is 2. submitted an affidavit dated 19.01.2015 for its willingness for adherence of provisions of new Regulations. A Revised Provisional Recognition Order was issued to the institution on 19.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two units) from the academic session 2015-2016.
- AND WHEREAS, the SRC in its 316th meeting held on 7th & 8th July 2016 and the 3. Committee decided as under: -
 - 1. Title deed is given. Title is clear.
 - LUC and EC are in order.
 - 3. BP is not legible.
 - 4. BCC is not given.
 - 5. Original FDRs and Approved Faculty list are not given.
 - 6. Processing Fee of only Rs. 40100 is given. Balance of Rs. 110000 remains to be collected.
 - 7. Collect full fee and cause inspection for shifting of B.Ed. (2 units).
 - 8. Ask VT to collect all relevant documents. They should assess adequately of facilities for both B.Ed. (2 units) & D.El.Ed.
- AND WHEREAS, as per the decision of SRC, the inspection of the institution was conducted on 07.09.2016 & 08.09.2016 and the VT Report received in the office of SRC on 26.09.2016.
- AND WHEREAS, The SRC in its 381st meeting held on 31st Oct & 01st Nov 2019 5. considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Further the Committee also suggested on receiving the reply to the SCN, the SRO may scrutinize the documents and still if there are some deficiency/lapses, the RD is authorized to issue Final SCN and then place the cases before the SRC for its perusal and decision. Accordingly, a Show Cause Notice was issued to the institution on 07.11.2019. In response, the institution vide dated 20.11.2019 submitted reply in response to the Final Show Cause Notice.

AND WHEREAS, the matter was further considered by the SRC in its 389th meeting held on October 12 & 14, 2020 and the Committee decided as follows: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee considered the Show Cause Notice's reply submitted by the institution on 20.11.2019 and found the following deficiencies: -

1. The institution has not submitted certified copy of registered land document.

2. The institution has submitted LUC in which Survey Nos. are not matched with the land document. The institution is required to clarify the same.

3. The institution has not mentioned Multi-purpose hall area in Building Plan & in BCC.

4. The institution has not submitted a notarized copy of Site Plan.

5. A Photocopy of Faculty List approved by Registrar, Andhra University consisting of one Principal and Fifteen Lecturers submitted vide dated Nil in which Date of Joining is not mentioned. The institution is required to submit the latest staff list (in prescribed format) duly approved by the Registrar, concerned affiliating body.

6. The institution has not submitted Form "A" issued by the Branch Manager. However, copy of FDRs submitted in totalling of Rs. 8 Lakhs but it requires

FDRs of Rs. 4 lakhs.

Therefore, the Committee decided to issue Final Show Cause Notice u/s 17 of NCTE Act, 1993 before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 21 days from the date of issue of Final Show Cause Notice.

NOW, THEREFORE, the institution is required to submit the representation/compliance accompanied with an affidavit from the authorized representation of the Management. The representation along with an affidavit must reach this office within the time specified at the end.

In case the reply submitted is incomplete or factually incorrect or not received in this office by the date mentioned at the end of this letter, then proceedings under Section 17(1) of the NCTE Act shall be brought to logical conclusion without any further opportunity provided in the matter whatsoever.

It is expected that your reply shall reach this office through Courier/Registered AD/ Speed Post only. NCTE does not expect applicants to personally visit the RC Office for any reason whatsoever.

Your reply, complete in all respects must reach this office within 15 days of the issue of this Final Show Cause Notice.
