FINAL SHOW CAUSE NOTICE U/S17

WHEREAS, the recognition was granted to the institution namely, **Vidyalaya College of Education, 4-32, S.B.I. Colony, Renigunta Road, Akkarampalli (Post), Tirupati-517507, Chittoor Dt, Andhra Pradesh** run by **Shirdi Sai Educational Society, 4/68, Tiruchuttu Street, Vayalpad, Chittoor District, Pin-517507, Andhra Pradesh** vide SRC (NCTE) recognition order No. **F.AP/NEW/B.Ed/88/SRO/NCTE/2002-2003/6717** dated **04.04.2003** for conducting **B.Ed. course** of one-year duration with an annual intake of **100** students from the academic session 2002-2003.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution is submitted an affidavit dated **19.01.2015** for its willingness for adherence of provisions of new Regulations. A Revised Provisional Recognition Order was issued to the institution on **06.05.2015** for conducting **B.Ed. course** of two years duration with an annual intake of **100** students (**two units**) from the academic session 2015-2016.

3. **AND WHEREAS**, the SRC in its 314th meeting held during 27th & 38th May 2016 considered the reply of the revised order and decided as under: -

"For cases of B.Ed (2 units) in the existing institution, where RPRO, had been issued. We have to cause inspection to check adherence to the 2014 Regulations. This action will have to be completed by July 2016 so that revised Formal Recognition can be issue w.e.f. 2016-17 to enable them to make admissions in time.

Action to check the documents in these cases (about 1885 in number) will take time. Instead of waiting for that action to be complete for placing them before the SRC, to save time, VT inspection can straightaway be ordered. VT inspection Reports can be considered along with examination of the documents.

Regional Director is authorized to initiate action accordingly. The institutions concerned may be alerted about such action so that they will be prepared to receive the visiting team they may also be advised to keep in readiness latest approved faculty lists for submission to the VTs."

4. **AND WHEREAS**, as per the decision of SRC an inspection letter was issued to the institution on 14.06.2016.

5. **AND WHEREAS**, on 06.07.2016 a letter is received by this office from the institution as under: -

"I submit that our Vidyalaya college of Education is a composite college which tuns M.Ed. B.Ed. and D.El.Ed. course.

We have applied for additional intake of 50 seats to the M.Ed course. As per the reference 2nd cited the NCTE team has visited our college and LOI has been granted recently.

As per the reference 3rd cited we are asked to pay 1,50,000/- towards the processing fee for conducting the inspection to the B.Ed programme.

Recently NCTE inspection team verified and satisfied the infrastructural, instructional facilities like land built up area, labs, library etc for two units of B.Ed. course and M.Ed. course. They personally verified of the staff which were approved by the Affiliating body viz S.V. University for B.Ed. and M.Ed. courses. The approved staff list for B.Ed and M.Ed course was already submitted to you.

In this regard I request that our college may be exempted from the NCTE inspection as per the reference 1st cited."

6. **AND WHEREAS**, the SRC in its 318th meeting held on 8th-9th August 2016 considered the matter and decided as under: -

1. According to earlier VT inspection report, built-up area is adequate. Therefore, another inspection is not required.
2. They have given a Faculty list that is approved by competent authority. But they have not given the original faculty list.

7. **AND WHEREAS**, the SRC in its 369th meeting held on 28.01.2019 decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC, a show cause notice was issued to the institution on **13.05.2019**. In response, the institution has not submitted the reply to the show cause notice.

8. **AND WHEREAS**, the SRC in 381th meeting held on 31st Oct & 1st Nov, 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT Repost accompanied with requisite documents in respond to RPRO issued by the SRC. Accordingly, as per the decision of SRC a final show cause notice was issued to the institution on **06.12.2019**. In response, the institution has submitted its reply on **31.01.2020**.

9. **AND WHEREAS**, the SRC in its 388th meeting held on 14th to 15th September, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee noticed that the institutions which were granted recognition on Rented Premises with a condition to shift its building to new permanent building. And, the institutions which have not yet shifted to its own permanent building.

1. The institution has not shifted its institution to own permanent building which is a **violation of the NCTE Regulations 2002, 3(c)**.

In view of the above, the Committee also perused the reply submitted by the institution on 31.01.2020. And the Committee found the following deficiencies: -

1. The institution has not submitted certified copy of registered land documents.
2. Built-up area, site area and multipurpose hall area is not readable in the building plan submitted by the institution.
3. Site plan is not approved by the competent authority and built-up area is not mentioned in the site plan.
4. The institution has not submitted Form 'A' issued by the Branch Manager. The institution is required to submit Form "A" issued by the bank manager towards creation of FDR of Rs. 7 lakh & Rs. 5 lakhs towards Endowment Fund & Reserve Fund.

Hence, the Committee decided to **Withdraw the recognition** granted to **Vidyalaya College of Education, Chittoor District, Andhra Pradesh** for conducting **B.Ed.** course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

10. **AND WHEREAS**, accordingly, as per the decision of SRC withdrawal order no. F.SRO/NCTE/APS00033/B.Ed/AP/2 020/118733-8739 dated **24.09.2020** was issued to the institution.

11. **AND WHEREAS**, on perusal of the records it is submitted that the institution was allowed shifting of the premises vide order/letter dated 03.12.2010.

12. **AND WHEREAS**, further the institution vide letter dated 05.10.2020 has represented the following:-

"We came to know through NCTE Website in 388th SRC Meeting held on 14th – 15th Sep, 2020 for our College in the same and style Vidyalaya College of Education, 4/32, SBI Colony, Renigunta Road, Akkaram Pali, Tiurpati, Chittoor District – 517507, Andhra Pradesh, has been Withdrawn. The reason for Withdrawn is that the institution has not shifted its premises to own permanent building, which is violation of the NCTE Regulations 2002, 3©.

However, we have already received our Shifting Order dated 03.12.2010 from the NCTE, hence, we are submitting the Shifting Order issued in SRC NCTE meeting 197th held on 13th – 14th Oct, 2010. We are again submitting all the relevant documents asked by the NCTE in the Show Cause Notice and the documents are as below:-

1. Shifting Order from SRC NCTE (Annexure – 1)
2. Certified Land Documents (Annexure – 2)
3. Land Use Certificate (Annexure – 3)
4. Non-Encumbrance Certified (Annexure – 4)
5. Approved Building plan along with Sire Plan (Annexure – 5)
6. Building Completion Certificate (Annexure – 6)
7. FDRs along with Form A (Annexure – 7)

8. *Staff List along with Certificate (Annexure – 8)*

Hence, we request you to kindly, issue the Continuation of Recognition Order for 2 units of B.Ed course for my institution."

12. **AND WHEREAS**, the matter was further considered by the SRC in its 389th meeting held on October 12 & 14, 2020 and the Committee decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

1. The institution has not submitted certified copy of registered land documents.
2. Built-up area, site area and multipurpose hall area is not readable in the building plan submitted by the institution.
3. Site plan is not approved by the competent authority and built-up area is not mentioned in the site plan.
4. The institution has not submitted Form 'A' issued by the Branch Manager. The institution is required to submit Form "A" issued by the bank manager towards creation of FDR of Rs. 7 lakh & Rs. 5 lakhs towards Endowment Fund & Reserve Fund.
5. The institution is required to submit latest staff list in the prescribed format duly approved by the affiliating body.

Therefore, the Committee decided to issue **Final Show Cause Notice u/s 17 of NCTE Act, 1993** before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 21 days from the date of issue of **Final Show Cause Notice**.

NOW, THEREFORE, the institution is required to submit the representation/compliance accompanied with an affidavit from the authorized representation of the Management. The representation along with an affidavit must reach this office within the time specified at the end.

In case the reply submitted is incomplete or factually incorrect or not received in this office by the date mentioned at the end of this letter, then proceedings under Section 17(1) of the NCTE Act shall be brought to logical conclusion without any further opportunity provided in the matter whatsoever.

It is expected that your reply shall reach this office through Courier/Registered AD/ Speed Post only. NCTE does not expect applicants to personally visit the RC Office for any reason whatsoever.

Your reply, complete in all respects must reach this office within 21 days of the issue of this Final Show Cause Notice.
