FINAL SHOW CAUSE NOTICE U/S 17

WHEREAS, recognition was granted to the institution namely to S.U.M College of Teacher Education, Mattanur P.O, Mamba, Kannur District-670611, Kerala vide SRC (NCTE) order no. F.KL/SEC/N/291/SRO/NCTE/2005-2006/5428 dt.14.02.2006 for conducting B.Ed. course of one year duration with an annual intake of 100 students for session 2005-2006.

AND WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education notified the Regulations, 2014 on 01.12.2014.

AND WHEREAS, the institution submitted a notarized affidavit consented to come under new Regulations dated 27.01.2015 and accordingly a Revised Provisional Recognition Order vide order no. F.No/SRC/NCTE/APSO0711/KL/2015-16/65240 dated 20.05.2015 was issued to the institution for 1 unit (50 Students) for session 2015-2016 with subject to fulfilment of certain terms & conditions.

AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st Nov,2019 and 387th meeting held on 24th & 25th August, 2020 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents. As per decision of above meeting a Show Cause Notice has been issued to the institution on dated 15.09.2020. But institution has not submitted any reply/documents till now against the Show cause Notice.

AND WHEREAS, the matter was further considered by the Sub-Committee constituted by the SRC as per decision taken in its 388th meeting held on 14th -15th September, 2020 and Sub-Committee of the SRC decided to issue **Final Show Cause Notice** to institution where reply has not been submitted by the Institution. In view of the above, the institution shall be required to submit/clarify the following observations were made: -

NOW THEREFORE, the institution is required to submit the representation/compliance accompanied with an affidavit from the authorized representation of the Management. The representation along with an affidavit must reach this office within the time specified at the end.

 The Institution is required to clarify about running of institution at rented premises/private lease/govt lease or land on ownership basis. If the institution running on rented or private lease basis as on date the

In case of change of premises from rented premises to permanent building and shifting permission is required, the institution is required to submit a DD amounting to Rs.1,50,000/- (Rs. One lakh fifty thousand only) in favour of the Member Secretary, NCTE, New Delhi alongwith prescribed application for shifting of premises.

 In case of no change of premises, the institution should note that there should be no change of land and building documents except the addition of built up area in the approved building. Therefore, the institution is required to submit land and documents submitted at the

time of recognition and the present status of the same.

- (iv) The institution is required to submit an attested/notarised copy of the approved Building Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an exclusive earmarked building plan for each of the recognised Teacher Education programme)
- (v) An attested/notarised copy of site plan showing all the plot/Survey No. mentioned in the land documents in one location alongwith land area and built up area.
- (vi) The Institution is required to submit an attested/notarised copy of Building Completion Certificate issued by the competent authority.
- (vii) The institution is required to submit Staff list duly approved by the Registrar of the affiliating body as per the prescribed Format. (In case the institution is running more than one teacher education programme, it is required to submit staff list duly approved by the Affiliating body for each of the recognised teacher education programme being run by the Institution.)

(viii) The institution has not submitted original FDRs to the SRC, NCTE The institution is required to submit a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years alongwith a copy of the FDRs.
