SHOW CAUSE NOTICE U/S 17

WHEREAS, the recognition was granted to the institution namely **S.R. D.Ed. College, Oguru Village, Kandakur Mandal, Prakasam Dist- 523105, Andhra Pradesh** run by **S.R. Educational and Rural Development Society, Prakasam District, Andhra Pradesh** vide SRC (NCTE) order no. F.SRO/NCTE/D.El.Ed/2008-2009/2419 dt 21.07.2008 for conducting D.Ed. course of two-year duration with an annual intake of 50 students from the academic session 2008-2009.

AND WHEREAS, the SRC in its 388th meeting held on 14th-15th September, 2020 had taken the following decision:-

"The Committee noted that reconsideration of RPRO matters which are accorded recognition before promulgation of Regulations 2014 has been undertaken by SRC and being considered in every meeting to verify the veracity of the institution who have complied with the Regulations 2014.

Further, the Regulations 2014 was amended on 09.06.2017 regarding staff eligibility. Some of the States have reported violations by the institutions with regard to admissions, not obtaining Affiliation etc.

Keeping in view the comprehensive scrutiny of institutions and also in view of further amendments of Regulations 2014, the matters were discussed by SRC and it was decided to ensure that all the recognized institutions are conforming to the Norms and Standards set by NCTE Regulations 2014.

In this regard, the Committee directed the Regional Director, SRC to issue a Show Cause Notices u/s 17 of NCTE Act, 1993 to all the institutions wherein Recognition was accorded by the SRC under Regulations 2014 with the direction to submit all requisite documents coupled with latest approved Staff list from concerned affiliating bodies. In case no reply or part reply to SCN is received by the SRC office. The RD is also authorised to issue Final SCN in all such matters."

NOW THEREFORE, the institution is required to submit the following documents/information:-

1. The Institution is required to clarify about running of institution at rented premises/private lease/govt lease or land on ownership basis. If the institution running on rented or private lease basis as on date the reason thereof for not shifting the premises to permanent building is required to be submitting by the institution. In case of change of premises from rented premises to permanent building and shifting permission is required, the institution is required to submit a DD amounting to Rs 1,50,000/- (Rs. One lakh fifty thousand only) in favour of the Member Secretary, NCTE, New Delhi alongwith prescribed application for shifting of premises.
2. In case of no change of premises, the institution should note that there should be no change of land and building documents except the addition of built up area in the approved building. Therefore the institution is required to submit land and documents submitted at the time of recognition and the present status of the same.
3. The institution is required to submit an undertaking that there is no charge in the name of Society/Trust(Management) which got the recognition of the institution as on date.
4. Keeping in view the points mentioned above. The institution is required to submit the following documents/clarifications for perusal of the SRC, NCTE-

- (i) The institution is required to submit certified copy of land documents issued by concerned Tehsildar /Revenue Officer. (If the same are in Regional Language the institution is also required to submit notarised copy of English version of land documents)
- (ii) The institution is required to submit an attested/notarised copy of Land Use Certificate issued by the Competent Authority
- (iii) The institution has not submitted a copy of Non-Encumbrance Certificate issued by the Competent Authority. The institution is required to submit an attested/notarised copy of Non - Encumbrance Certificate issued by the Competent Authority.
- (iv) The institution is required to submit an attested/notarised copy of the approved Building Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an exclusive earmarked building plan for each of the recognised Teacher Education programme)
- (v) An attested/notarised copy of site plan showing all the plot/Survey No. mentioned in the land documents in one location alongwith land area and built up area.
- (vi) The Institution is required to submit an attested/notarised copy of Building Completion Certificate issued by the competent authority.
- (vii) The institution is required to submit Staff list duly approved by the Registrar of the affiliating body as per the prescribed Format. (In case the institution is running more than one teacher education programme, it is required to submit staff list duly approved by the Affiliating body for each of the recognised teacher education programme being run by the Institution.)
- (viii) The institution has not submitted original FDRs to the SRC, NCTE. The institution is required to submit a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years alongwith a copy of the FDRs.

- (ix) Details of Teacher Education programme (s) being run by the Institution in the same campus

- (xiii) The institution shall be required to submit an Affidavit clearly stating status about land & building and Management (Society/Trust) at the time of recognition and its present status giving following details

- (i) Details of land & building available at the time of recognition with the Institution
- (ii) Details of land & building now available with the Institution
- (iii) Status of Management at the time of recognition and its present status

In case of change of land & building or the Management at the time of recognition and thereafter the institution is required to specify the reason thereof with approval of the SRC, NCTE.

NOW THEREFORE, the institution is required to submit the representation/compliance accompanied with an affidavit from the authorized representation of the Management. The representation along with an affidavit must reach this office within the time specified at the end.

In case the reply submitted is incomplete or factually incorrect or not received in this office by the date mentioned at the end of this letter, then it shall be treated as incomplete reply to the terms of this notice.

It is expected that your reply shall reach this office through Courier/Registered AD/ Speed Post only, NCTE does not expect applicants to personally visit the RC office for any reason whatsoever.

Your reply, complete in all respects must reach this office within 21 days of issuance of this notice.
