#### ORDER

AND WHEREAS, the recognition was granted to the institution namely, Namboodiris College of Teacher Education, Marar Road, West Nada, Irinjalakuda, Thrissur District- 680121, Kerala vide SRC (NCTE) restoration recognition order No. F.KL/SRO/NCTE/2008-09/4319 dated 28.08.2008 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2005-2006.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted an affidavit dated 19.01.2015 for its willingness for adherence of provisions of new Regulations.
- AND WHEREAS, a Revised Provisional Recognition Order was 3. issued to the institution on 13.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (Two basic units) from the academic session 2015-2016. A corrigendum issued to the institution vide order No. F.SRO/NCTE/APS07135/B.Ed./KL/2015/69537 dated **03.07.2015** for conducting B.Ed. programme of two years duration with an annual intake of 50 for one basic unit from the academic session 2015-16.
- AND WHEREAS, the SRC in its 381st meeting held on 31st Oct &  $01^{st}$  Nov, 2019 and  $387^{th}$  meeting held on  $24^{th}$  &  $25^{th}$  August, 2020 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents. Accordingly Show Cause Notice was issued on 02.09.2020. Reply of Show cause notice vide letter dated 01.10.2020 received in SRC office 05.10.2020.
- AND WHEREAS, the matter was further considered by the SRC in its 392th meeting held on October 28th -29th, 2020 and the Committee decided Final Show Cause Notice Issue to the institution. Accordingly Final Show Cause Notice was issued on 12.12.2020. The institution has submitted reply received in SRC office 12.01.2021.

AND WHERAS,** the matter regarding compliance by the institutions of the conditions of the revised recognition order was placed before the SRC in its  $394^{th}$  meeting held on  $05^{th}$  -  $06^{th}$  January 2021 and the committee decided as follows:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution Namboodiris College of Teacher Education, Marar Road, West Nada, Irinjalakuda, Thrissur District-680121, Kerala for B.Ed programme for 1 basic unit of 50 students."

- 7. NOW THEREFORE, this order is issued permitting the institution continuation of conducting Namboodiris College of Teacher Education, Marar Road, West Nada, Survey No. 50/5, Irinjalakuda, Thrissur District- 680121, Kerala run by University of Calicut for B.Ed. course of two years duration with an intake of 50 students (One basic units) subject to fulfillment of the following conditions:
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation form the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **8.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.

- 9. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme (s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e. Fee charged from students;
  - f. Available infrastructural facilities;
  - g. Facilities added during the last quarter;
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
  - i. The affidavit with enclosure submitted along with application.
    - j. The institution shall be free to post additional relevant information, if it so desires.
    - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
  - 11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
  - 12. The institution shall make available the list of students admitted on its official website.

13. The institution shall fill the information on GIS Portal on the NCTE Website. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued thereunder, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
