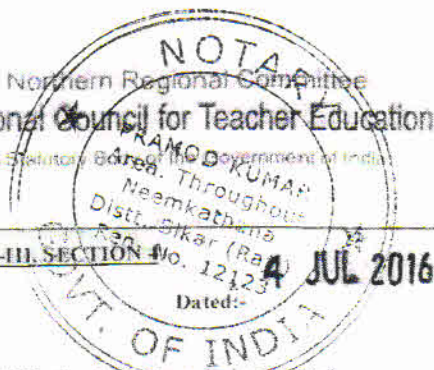

RECOGNITION ORDER
