#### Academic Faculty 5.1

For an intake of two basic units of 50 students each, that is total students strength of 200, there shall 16 full-time faculty

The distribution of faculty across different curricular areas shall be as under:

1.	Principal / HoD	One
2.	Perspectives in Education	Four
3.	Pedagogy subjects	Eight
	(Maths. Science, Social Science, Language)	0
4.	Health and Physical Education	One
5.	Fine Arts	One
6.	Performing Arts (Music/Dance/Theatre)	One

The faculty positions listed under different subject categories may teach course(s) in the Teacher Education Programme across curricular areas specified, and can cater to both foundation and Note: pedagogy course(s). If the students strength for two years is one hundred (with one basic unit) only, the number of faculty shall be reduced to 8.

Faculty can be utilized teaching in flexible manner so as to optimize academic expertise available. (ii)

#### Qualifications 5.2

The faculty shall possess the following qualifications:

- Postgraduate degree in Arts / Sciences / Social Sciences / Humanities/Commerce with minimum 55% Principal / HOD (i) marks; and
- M.Ed. with minimum 55% marks; and (iii)
- Ph.D in Education or in any pedagogic subject offered in the institutions; and
- Eight years of teaching experience in a secondary Teacher Education Institution.

Desirable: Diploma/Degree in Education Administration or Educational Leadership.

Perspectives in Education or Foundation Courses B.

Postgraduate degree in Social Sciences with minimum 55% marks; and M.Ed. degree from a recognized university with minimum 55% marks.

OR

Postgraduate (MA) degree in Education with minimum 55% marks; and

B.Ed./B.El.Ed. degree with minimum 55% marks.

Curriculum and Pedagogic Courses

Postgraduate degree in Sciences / Mathematics /Social Sciences/Languages with minimum 55% marks; (i) and

M.Ed. degree minimum 55% marks

Desirable: PhD degree in Education with subject specialisations.

In case of B and C put together, for two faculty positions, a postgraduate degree in Sociology/Psychology/Philosophy with 55% marks, and B.Ed. /B.El.Ed. with 55% marks and three years of teaching experience in a secondary school shall be considered].

Specialised Courses Physical Education

Master of Physical Education (M.P.Ed.) with minimum 55% marks. (Training/qualification in yogs education shall be desirable)

Post graduate degree in Fine Arts (MFA) with minimum 55% marks



- 8. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
- 9. Further, if the institution is not satisfied with the order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website <a href="www.ncte.india.org">www.ncte.india.org</a> within 60 days from the date of this order.
