Restoration of Recognition Order

Whereas, recognition was granted to the institution namely **Yadav B.Ed. College, At - Mangalpur, Tal. - Keshod, Junagadh, Gujarat - 362001** for conducting B.Ed. course vide order no. No.WRC/5-6/90/2006/11613 dt. 30.10.2006.

And whereas, recognition was withdrawn on **18.12.2008** as per decision of **110th** meeting of WRC.

And whereas, the matter was considered by WRC in its **145th** meeting in the light of judgment of the Hon'ble High Court of Gujarat at Ahmadabad in **SCA No. 3205 of 2009** and related matters and decided to cause inspection. The inspection of the institution was conducted on **05.05.2011**.

And whereas, the visiting team report was placed in **150th** meeting of WRC and the committee decided to issue Show Cause Notice.

And whereas, as per decision of **150th** meeting Show Cause Notice issued on **22.06.2011**. Institution submitted the reply to Show Cause Notice on **23.07.2011**.


And whereas, the reply to Show Cause Notice placed in before **153rd** meeting of WRC. As per decision of WRC withdrawal order issued on **01.10.2011**.

And whereas, the matter was considered by WRC in its **166th** meeting in the light of judgment of the Hon'ble High Court of Gujarat at Ahmadabad in **SCA No. 6489 of 2012** and decided to issue Show Cause Notice. As per decision Show Cause Notice issued on **21.08.2012**.

And whereas, the reply to Show Cause Notice placed in before **176th** meeting of WRC. As per decision of WRC clarification issued on **04.03.2013**.

And whereas, WRC considered the reply in **182nd** meeting and observed that the institution has rectified all the shortcomings. Hence the recognition is restored.

Revised Order

Whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

2. And whereas, the Yadav B.Ed. College, At. Mangalpur, Tal-Keshod, Junagadh Gujarat-362001 by affidavit dt. 28.01.2015 has consented to come under new Regulations and sought for two basic units in B.Ed, which require additional facilities

3. And whereas, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,

- I. The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- II. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
- III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- IV. In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted along with the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Western Regional Committee in respect of Section 17/complaint cases etc.

4. Now therefore, in the light of the above and in accordance with the NCTE Regulations, 2014, the Western Regional Committee (NCTE) hereby issues the revised recognition order to Yadav B.Ed. College, At. Mangalpur, Tal-Keshod, Junagadh Gujarat-362001 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16 subject to fulfillment of the conditions mentioned herein before 31.10.2015.



5. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.
6. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.
7. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
- Sanctioned programmes along with annual intake in the institution;
 - Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - Name of faculty members who left or joined during the last, quarter;
 - Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - Fee charged from students;
 - Available infrastructural facilities;
 - Facilities added during the last quarter;
 - Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - The affidavit with enclosure submitted along with application.
 - The institution shall be free to post additional relevant information, if it so desires.
 - Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.

8. Recognition order no. WRC/5-6/90/2006 dt. 30.10.2006 & WRC/APW02087/323243/182nd /2013/02581-102587 dt. 04.05.2013 be treated as cancelled from the date of issue of this revised order.

WHEREAS, recognition/permission was granted to the institution **YADAV B.ED. COLLEGE, SARVODAY EDUCATION TRUST, AT - MANGALPUR, TAL. - KESHOD, DIST. JUNAGADH-362001, GUJARAT**, under Section 14 of NCTE Act, 1993 for conducting **B.ED. Course** with an intake of 100 students vide order No. WRC/5-6/90/2006 dt.30.10.2006.

2. And whereas, the recognition was withdrawn vide order No. WRC/APW02087/323243/110th/2008/48209-48214 dt. 18.12.2008 as per decision of 110th meeting of WRC.

3. And whereas, the matter was considered by WRC in its 145th meeting in the light of the direction of the Hon'ble High Court of Gujarat at Ahmedabad in SCA No.3205/2009 and related matters and decided to cause inspection. The inspection of the institution was conducted on 05.05.2011. The VT report was placed in 150th meeting of WRC and the Committee noted that the following deficiencies exist vis-à-vis NCTE norms:-

1. Part of the building is covered by tin/asbestos sheets.
2. Staff list approved by the affiliating University not submitted.
3. Principal not appointed.
4. The land documents duly certified by the competent authority was not submitted along with the application that was required as per the section 7(d) of NCTE Norms and Standards 2002 or as Section 8(5) of NCTE Norms and Standards 2005.


4. And whereas the Show cause notice was issued to the institution vide letter No. WRC/APW02087/323243/150/2011/79089 dt. 21.06.2011.

5. AND WHEREAS, the reply submitted by the institution was considered by the WRC Committee in its 153rd meeting held on 28th-30th, July, 2011 and having taken into consideration all the relevant facts of the case, it was decided to withdraw recognition for conducting B.ED Course from the end of the academic session next following the date of this withdrawal order.

6. Now, therefore, recognition to **YADAV B.ED. COLLEGE, SARVODAY EDUCATION TRUST, AT - MANGALPUR, TAL. - KESHOD, DIST. JUNAGADH-362001, GUJARAT** for the B.ED course in terms of Section 17(1) of the NCTE Act, 1993 is hereby withdrawn from the end of the academic session next following the date of this withdrawal order on the following grounds:-

1. Principal not appointed.

7. The affiliating body/State Govt. are advised not to admit/allot any student to **YADAV B.ED. COLLEGE, SARVODAY EDUCATION TRUST, AT - MANGALPUR, TAL. - KESHOD, DIST. JUNAGADH-362001, GUJARAT**. As per Section 17(4) of NCTE Act, 1993, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government.
